ICCARTHY WINS FIRST MAJOR TITLE AT 2022 U.S. WOMEN'S (

SOUTH GLENS FALLS, N.Y. - In what's been a popular method to win on the Professional Women's Bowling Association Tour this season, Erin McCarthy of Elkhorn, Nebraska, climbed the ladder to win the 2022 U.S. Women's Open.

The 31-year-old right-hander defeated Danielle McEwan of Stony Point, New York, 212-172, to win her first career major title Tuesday at Kingpin's Alley Family Fun Center. She is the fifth player this season to successfully climb the stepladder to capture a title.

McCarthy earned the coveted green jacket, iconic trophy and \$60,000 for the win. The U.S. Women's Open was broadcast live on CBS Sports Network.

In the title match, McCarthy opened with three consecutive strikes and tossed five in the first six frames to sprint to a 28-pin advantage. McEwan was slow to get out of the gates with just one strike and two open frames during the same period. The lead continued to increase for McCarthy as McEwan was unable to double during the final four frames, allowing McCarthy to lock up the match.

On Monday night, McCarthy had to throw two strikes in the 10th frame to earn the No. 5 seed and advance to the finals. On Tuesday night, McCarthy earned her place in the record book as the latest U.S. Women's Open champion

"Fifty-six games plus these are grueling," said McCarthy, who won her second PWBA Tour title and first since

2018. "You've got bad games and really good games. The highs and lows of the tournament, it is beyond stressful. There were a lot of nerves, but even more nerves in that final game. I just really focused on one shot at a time. I made sure that my feet were slow, because if my feet were slow, everything else should align appropriately. To make it here to the top, this is the greatest moment of my life. This is going to be something that I never, ever forget."

McCarthy was one of four players in the stepladder with previous championship-round experience at the U.S. Women's Open, recording third-place finishes in 2017 and

2018. Despite neither event resulting in a win, she learned from those experiences and applied some valuable lessons Tuesday, which helped steer her to the winner's circle.

"This feels absolutely incredible," said McCarthy, who is the eighth different PWBA Tour champion this season. "I think from my past two U.S. Open shows, I learned what not to do for this one. I rushed a lot during those shows. The 10 frames go by super quick, and I'm a quick bowler to begin with, so I forced myself to stay slow during the show. Last night, I went to bed and thought about what I was going to do differently today. I did everything differently today than I did on those last two shows, and it paid off."

McCarthy advanced to the title match after defeating No. 2 Jordan Richard of Maumee, Ohio, 235-206. A late rally by Richard forced McCarthy to mark in the 10th frame to advance to the title match. She delivered a strike

In Match 2, McCarthy was locked in a battle with twotime PWBA Player of the Year Shannon O'Keefe of Shiloh, Illinois. After McCarthy failed to shut out O'Keefe, the 15-time champion needed two strikes and eight pins to advance. O'Keefe struck on the first two offerings but left the 4-6-7-9-10 split on her fill ball to lose, 220-218.

In the opening match, McCarthy defeated Singapore's Shayna Ng, 212-178. McCarthy led by four pins in the continued on page 2

E BORESCH JR. GETS A MAJOR WIN AT 2022 PBA SENIOR U.S. OPEN

LUBBOCK, Texas -Lennie Boresch Jr. had himself a day on Wednesday at the 2022 PBA Senior U.S. Open. He went 12-4 during two match play rounds, including winning his final six matches.


He started the day in 10th place and climbed into seventh after the second round of match play. He then defeated Jack Jurek in the position round 257-213 to earn the top spot in the stepladder finals. He credits his success to changing to a Roto Grip RST X-1 before the last game of match play round two and it worked out well. It's a ball he has had a lot of success with, plus it allowed him to play direct lines, which he admits he is pretty good at doing.

"I overtook him (Jurek) to get that top seed and that was huge," Boresch Jr. said. "I figured he would be there at the end, and he was."

As Boresch expected he would once again face Jurek but this time in the championship match inside South Plains Lanes for the chance to win a major title.

Jurek, who finished fourth at last's weeks USBC Senior Masters, started out nine-spare strike to Boresch's double. In the third frame, Jurek went through the nose leaving the 3-4-6-7-10 split getting just the 6-10 for an open frame. Boresch stayed clean until the fifth frame when he left a pocket 7-10

"When I left it (7-10), I



said I am not going to let it get me down," the Wiscon-

sin native admits. He responded with three-in-a-row. Jurek was clean until the ninth frame when he tugged his shot

2022 Senior U.S. Open Champion Lennie Boresch Jr. leaving the 4-7-10, which he failed to convert posting a score of 168 in the foundation frame. Boresch stepped up on the right lane and struck then struck again on his first ball in the

10th which resulted in a fist pump. He got the win 233-

"It was nerve racking as hell and pretty emotional because I didn't know if it would ever happen again, let alone a major," he said, especially after at least half a dozen runner-up finishes. "I made some pretty good shots down the stretch. I was fortunate enough to carry them out of there to become the Senior U.S. Open champion."

His last title was at the 2018 PBA50 National Championship in The Villages, also a major. He now has five PBA50 titles with two being majors. And he earned the \$12,500 firstplace prize.

"Now I am Hall of Fame eligible," the 60-year-old

said. "It's a goal that was in the back of my mind."

Boresch was originally planning to cut back on bowling tournament this season, but he will continue to ride his current hot hand that has carried over between the USBC, the Masters and the Super Senior Classics he bowled in Las Vegas.

"One of my better days ever," he said. "It's an unbelievable feeling. I'm beat up right now, but as long as I am bowling good, I'm going to keep going."

In the opening match, Amleto Monacelli defeated 2022 USBC Senior Masters champion Dino Castillo. They combined for five open frames, and it was a six-bagger by Monacelli continued on page 2



Thanks For The Memories

Many thanks to Carol Mancini and Dean Lopez for their kind words in the last issue of the California Bowling News. The newspaper has been such a big part of my life since the days that I was recording all of those 300 games in so many different bowling centers in California, beginning in 1972 (wow, 50 years ago!). Bowling has been a labor of love for me since I first rolled a ball down the lane at the age of 8. My first two rolls of the ball were strikes!

"Curious" Carol had a few questions for me, and in honor of Jim Dressel, former editor of Bowlers Journal International, I will answer those questions in his Q & A format. This should be fun because I have many more memories and humorous stories that I have never told. I hope that the readers will enjoy them!

How much space does your memorabilia take up?


I have one of my two bedrooms filled with trophies, plaques, cherished clippings and magazine articles, as well as a few bowling balls and other one-of-a-kind bowling pins, telescore sheets (remember those?) and other collectibles. And then there's my "Mini-Storage Locker Museum" a couple of blocks from home that contains the bulk of my paraphernalia.

Included in the storage locker are file box after file box of everything imaginable from the world of bowling — old PBA annuals and media press kits, posters, banners, bowling balls and pins from research and design projects, Angle WinningWear prototypes, instruction and training binders too numerous to mention, and oodles of paper... including at least two file boxes of complete issues and clippings from the California Bowling News.

If there's ever an episode of "Hoarders" that involves paper, I would qualify as a candidate!

Are you a member of the "Million Air Miles" club?

I am a member of the club. When you consider that each round trip to Sydney, Australia amounted to almost 20,000 miles, you can see how those miles add up quickly. Some of the other most frequent international trips that I made while at AMF included Hong Kong (about 16,000 miles round trip), Tokyo (14,000 miles), and London (7,000 miles).

And let's not forget trips within the United States. That's where most of my miles were logged. Excursions to Los Angeles, San Francisco, Seattle and Portland were each about 5,000 miles round trip from New York or Richmond, while Dallas/Ft. Worth clocked in at close to 3,000 miles and Orlando 1,000 miles. Those were my most recurrent destinations, along with many midwest destinations (Chicago, Columbus, Detroit and St. Louis among the most frequent).

Looking back on it now, I wonder if subconsciously those trips were one of the reasons that I chose to leave AMF, because each journey placed a cumulative amount of pain upon my back and sciatica. The trip to Australia was particularly painful at times. I used to break it up by flying first to Los Angeles, then to Hawaii, then Auckland, and finally Sydney or Melbourne.

I wonder if Jason Belmonte has back problems?

How many times have you moved?

So many times I have made reference to the year that I moved 7 times while working for AMF; and while that is true, I was actually using my parent's address as a home base and living in efficiency motels. But in actual moves that involved more than a year of residency, there have been ten, listed here in chronological order: San Diego, Burbank, Las Vegas, Portland (Oregon), Chicago, Seattle/Tacoma, Westbury (New York), Richmond (Virginia), Sacramento, and finally Edison, a town of about 100,000 residents in New Jersey.

My favorite location would have to be San Diego, for the fabulous weather; and my least favorite would have be Chicago, for the severe weather. One of my favorite weather stories involves my time in Chicago. As I was preparing to host a get acquainted party for a company at Strike 'n Spare Lanes, home of the Jerry Lewis Muscular Dystrophy Telethon for many years, I heard a "beep-beep-beep" warning come across the television signaling that a tornado was in the area.

I called the bowling center to let them know that because of the tornado, I would not be there later

that evening. They never let me live that down for the entire time that I was in Chicago, because a tornado warning to them was like an earthquake with a magnitude of less than 1 on the Richter magnitude scale. You live, and learn!

Name 5-10 cars that you have owned?

You must be psychic! I've owned 10 cars in my lifetime. The first was a hand-me-down from my sister that was financed by my father. When my sister married, I took over the monthly payments on a Chevy Malibu Super Sport. The car was a baby blue metallic convertible that could only be classified as a "girly car" in the 1960's.

I couldn't wait to get my own car and worked every summer for my dad as a shipping clerk until I was able to purchase a 1971 jet black Mustang (with black interior) for \$3,700. It was custom built direct from the factory, something that the Ford Motor Company used to allow, with a 351 "Cleveland" engine, 302 horsepower, Hurst linkage and four on the floor.

Because the climate is quite mild in Sonoma County, I ordered the car without air conditioning. That proved to be fatal when AMF moved me to Las Vegas a few years later, and the plastic coated steering wheel actually melted! I know that I've told this story at least once before, so I'll keep it brief... I arrived in Las Vegas on the evening of July 4th at 10:00PM. The temperature on a bank sign said that it was 104 degrees. I checked into a motel and looked forward to an early start the next morning.

It was 9:00AM when I arrived to meet Betty Lenahan, manager of New College Park Bowl on North Las Vegas Boulevard. I locked my car and was in the bowling center until about 10:00PM that night learning many of the administrative procedures. When I went out to my car, the plastic coated steering wheel had melted and the dash board had split open from the extreme heat. You see, no one told me to roll down the window an inch or two... again, you live and learn!

I'm only about half way through "Curious" Carol's questions, so I'm going to take a pause here and we'll finish up next week with the other 8 cars, and many more memories.

INDIANA'S BRYAN DECK CONNECTS FOR 900 SERIES

ARLINGTON, Texas - Bryan Deck of New Castle, Indiana, wasn't really in the mood to bowl his summer league Monday. However, after a trip to visit his father's gravesite, Deck decided to heed the advice his dad would've given him, which was to go out and bowl anyway since it's something that he loves to do.

The adage that "father knows best" came true in staggering fashion as Deck went out and delivered strikes on all 36 balls he threw that night to record a 900 series during the Summer Chase the Cash league at Rose City Bowl in New Castle, Indiana.

Deck, a 44-year-old right-hander, has been a competitive bowler for many years, carrying a 200-plus average across multiple leagues and participating in several local and regional tournaments as well; however, until Monday, honor scores had been relatively tough to come by as Deck had just one 300 and one 800 (812) on his bowling resume up to that point.

"After I shot 300 the first game, I thought I had a chance to beat the 812 series I had a couple of years ago, and that was as far down the road as my mind was going at that point," Deck said. "When I went into the 10th frame of Game 2, I was expecting a 10 pin or something like that to pop up like it usually does, but that just didn't happen."

It didn't, so Deck continued striking as action got underway in Game 3. However, when he reached the middle of that game, the nerves and emotion of all that had taken place so far started to catch up to him.

"When I got to the fifth frame of the third game, I thought I was going to pass out; I felt like I was just about to collapse," Deck said. "But then it felt like something took over for me. It may sound crazy, but it was like my dad got into my body and threw the last five-six shots for me."

When those final shots were thrown and all of the pins had fallen, Deck was left to come to grips with the enormity of what he had just accomplished, which is something he is still trying to do several days later.

"I never would've thought in a million years that I'd shoot a 900," Deck said. "When it happened, I knew it would be a big deal, but I never imagined anything like this. It means the world to me to be part of such a small number of bowlers to have done it."

Deck has always wondered what it would be like to give professional bowling a try as he's had multiple friends and fellow bowlers suggest that it's something he should consider. Deck acknowledged that shooting 900 doesn't automatically mean that he's ready

to bowl with the pros; nevertheless, he also pointed out that his accomplishment did land on the radar of some of the Professional Bowlers Association Tour's biggest stars.

"EJ Tackett and Ronnie Russell reached out to me, and they said that they'd be nervous for something like that to happen to them, so for them to contact me shows that this is an even bigger achievement than I thought," Deck said.

The only problem that Deck has now, from a bowling perspective, is figuring out where to go from here.

"I don't feel like I'm better than anybody because I bowled 900, but this does make me wonder what my standards should be," Deck said. "I'm trying to make sense of it all, but I can't."

No matter what path Deck's bowling career follows from this point forward, nobody can ever take away what he accomplished in shooting 900 and the role that his father's memory may have played in helping him do so.

The series is pending approval from the United States Bowling Congress. If approved, it would be the third perfect set in Indiana and 40th USBC-approved 900 overall.

Bob Kammer Jr. of Crown Point was the first to roll a 900 in the Hoosier State; he accomplished the feat in January of 2011. John Buchanan III of Evansville achieved the perfect set in January of 2017.

The first USBC-approved 900 occurred Feb. 2, 1997, when Jeremy Sonnenfeld rolled three consecutive perfect games in Lincoln, Nebraska.




