EJ TACKETT ADDS TO LEGACY WITH SECOND U.S. OPEN TITLE

Tackett completes monumental comeback for sixth career major

After two rounds of qualifying in the 2025 U.S. Open presented by Go Bowling, EJ Tackett found himself in 78th place and almost 200 pins outside the cut.

Four days later, Tackett left Indianapolis' Royal Pin Woodland with his second U.S. Open title, green jacket and the \$100,000 top prize.

Tackett, who climbed all the way to the No. 2 seed after 48 games of qualifying and match play, defeated top seed Andrew Anderson in the title match 238-184, claiming the season's first major championship and his second U.S. Open crown in three years.

"It's just as emotional for different reasons," Tackett said, reflecting on his 2023 win. "Two years ago, I

came back after losing (in 2022) and was able to win. This time, I won the U.S. Open as a dad. I know I won the PBA World Championship last year and Tripp was there, but this is the U.S. Open, man."

Tackett has always revered Royal Pin Woodland, the only venue to have hosted all five PBA major championships.

The Huntington County native grew up less than two hours north of the iconic bowling center, dreaming of winning a PBA Tour title on its hallowed grounds and joining the PBA legends whose championship banners forever hang from its rafters.

"Woodland is synonymous with major championships, especially this one," Tackett said. "It's hard to

put it into words. I'm so grateful and lucky to have such a great bowling center, and so much history in my backyard. To be fortunate enough to win here twice, it's just special."

Tackett bowled his first U.S. Open at Woodland when he was only 16. This year, he became the 13th player to win multiple U.S. Open titles.

Over the past two seasons and change, in which Tackett has won four of 11 major championships, he has silenced any doubters who questioned whether or not he can consistently succeed at the highest level.

"I've never, ever questioned my ability," Tackett

A Renaissance of Bowling...

What's Happening In New Jersey???

There's something happening in the state of New Jersey, "But what it is ain't exactly clear," as the famous line from the Buffalo Springfield song ("For What It's Worth") of 1967 laments. But in this case, it's a time of celebration, as bowling is making a comeback in the Garden State!

A few weeks ago, I made mention of the surprising return of Stelton Lanes in Piscataway, reopening as Circle Bowl-Piscataway. The center had been closed since 2020 due to the COVID-19 virus, and many believed that according to reports, the center would be converted into an Asian supermarket. But it never happened.

Instead, a couple of entrepreneurs from northern New Jersey decided to acquire the location and convert it into Circle Bowl-Piscataway, the third in a chain of bowling properties owned by Keith Dougherty and Shawn Aiello. My exclusive interview with Shawn appears in the February issue of BCM Magazine, the official publication of the BPAA. Here's the link (article begins on page 50):

A couple of weeks after, while doing research online for a different column, I noticed yet another new facility that had opened near Rutgers University in New Jersey — Palmeras Entertainment Center (palmerasentertainment.com). The two story facility features a giant replica outdoor bowling pin, like the one displayed at USBC Headquarters in Arlington, Texas.

This week, while trying to decide on a topic for the "Dave's Corner" column, I found an amazing four more bowling centers that will be opening soon in and around Edison, New Jersey!! I wonder if this is happening across the country, or if it's unique to this area — please let me know if you are seeing this same phenomenon in your area.

It's never wise to bring politics into a conversation, but you have to wonder if part of this newfound bowling interest is the "Trump effect." Nothing else has changed, so why the sudden interest in bowling? I think that Trump's easing of regulations just might be the stimulus that was needed. In fact, I just noticed a proclamation from the White House stating that whenever an agency of the federal government promulgates a new rule or regulation, at least 10 existing rules or regulations must be repealed (whitehouse.gov fact sheet).

A Plethora of Bowling Activity

Take a look at all of these new bowling center announcements from the area in and around Edison. A news release that especially caught my eye was the report of not one, but two Round 1 Entertainment locations to compliment another facility that has already opened in the Deptford Mall in Deptford, N.J., not far from Philadelphia. The two new sites will also be inside malls: one at the Jersey Gardens Mall (near Newark International Airport), and another at the Menlo Park Mall, which is just a couple of minutes from where I live.

The main question everyone is asking, according to Alex Lesniak of the CMS Post, is where the Round 1 location will be within the Menlo Park Mall. "My best bet is right next to Macy's in the former Fox and Hound Restaurant and Bar," said Alex. "This would provide an exterior entrance, as well as access from inside the mall."

Here are some other recent announcements regarding new bowling locations:

Launch Entertainment: This will be the second site for Launch Entertainment in New Jersey. The other is in the Court at Deptford, a short walk across the street from Round 1 Entertainment in the Deptford Mall. Both WPST 94.5FM Radio and NJ.com have announced plans for the new location in Edison, but when and where the venue will be is unclear. Launch features a number of indoor activities, highlighted by bowling and trampoline courts.

810 Billiards and Bowling: Recognized as an upscale entertainment and bar experience, the South Carolina based chain has recently targeted the Dallas/Ft. Worth region, where the area to the south of the Metroplex is calling out for new entertainment, according to editor Alex Locke of 1851 Franchise. He reports that plans are also underway for two more locations in Phoenix.

"South Carolina and Arizona hold some of the fastest growing suburbs in the country," said Mike Sinisalchi, CEO of 810 Billiards and Bowling. "And Dallas may be the fastest, with an estimated 1.3 million people projected to relocate there in the next decade."

Currently 810 Billiards and Bowling have locations in South Carolina (4), Florida (2), Arkansas, Virginia, Phoenix, Houston and Vineland (near Philadelphia). The Edison property would be their second in New Jersey.

I wonder if the founder is a lousy bowler (8-10 split)?

Monster Mini Golf: This isn't really traditional bowling, but I did notice a center in the mall adjacent to my neighborhood supermarket. They incorporate AMF's Highway 66 Mini Bowling, which I didn't realize until researching all of these new bowling center rumblings.

Monster Mini Golf has more than 30 locations in the USA and Canada, including 7 in Texas and 6 in New Jersey. The glow-in-the-dark facilities are populated with animated "monsters" that move, talk and at times tell silly jokes, according to their website.

Edison has been without a bowling center since the closing of Brunswick Edison Lanes, a 40 lane facility located on Oak Tree Road, more than 20 years ago. Prior to that, Edison was also home to the largest bowling center in the world, Edison Lanes, featuring 112 lanes all in a row. The latter permanently closed in 1986.

With a population of 107,588 (2020 census), Edison is the sixth-most populated municipality in New Jersey. It's about time that someone recognized the need for bowling in the area, but four new location announcements in one week makes me say, "Hooray for our side."

said. "It was just a matter of being able to perform on television where I lacked for a lot of my career. The last couple years, I have been really, really good at building on that and using everything that I've learned to perform well in these situations, whether I win or not. All I have control over is me performing well. If I can go out and do that, I can always hang my head high and know that I did everything that I could. That's the mindset I have going into TV shows now, to bowl the best that I possibly can, and everything else will take care of itself."

Tackett left back-to-back stone 9-pins to start the championship match. After that, he thoroughly dominated Anderson, who led the tournament nearly wire to wire. A few errant shots from Anderson would be all the margin Tackett needed to clinch the win before the 10th frame.

In the semifinal, Tackett fired seven straight strikes to build a lead Chris Via stood no chance of overcoming. Via lost all control of the match, low-lighted by his sixth frame in which he knocked over five total pins.

Via, the 2021 U.S. Open champion, disbarred two-time U.S. Open champion François Lavoie in the second match, firing eight strikes in his first nine frames.

Lavoie spared three consecutive 10-pins early in the opening match against Anthony Simonsen, who advanced to the championship round by winning the preliminary stepladder on Saturday afternoon. The tide turned when Simonsen left back-to-back splits in the sixth and seventh frames.

Tackett, the three-time and two-time reigning PBA Player of the Year, is off to another strong start to the 2025 season.

The PBA Tour continues on Tuesday with PBA Owen's Illinois Classic qualifying.

REDLANDS – Tim Frank rolled a **712** sanctioned scratch series in the Senior Laughlin League topping every **"JOE BOWLER"** competing in the league. Tim not only rolled the High Scratch Series of the week he also rolled the High Scratch Game (**289**). This dual high is an outstanding accomplishment and cemented Tim's selection for this week's "Senior Bowler of The Week".

Tim is also maintaining the **highest senior league average** (211) at Empire Bowl this season. His average is astounding all of us senior bowlers here since the installation of **String Pins** last March. Since then only about half a dozen senior bowlers have been able to average 200 in all four of our mixed senior leagues combined. One of those leagues doesn't even boast a single bowler averaging 200!

Besides carrying the highest senior league average in the house, that average is nearly 10 pins higher than the second highest senior league average at Empire Bowl.



Bowlum Stirkes To A Third Round Win

DOWNEY – The Brunswick Invitational took the lanes for the last week of the third round with two teams still alive with a shot at the round. Bowlum held a four-game lead over US Foods with US Foods needing a sweep to win the round.

In the “A” match, the only match relevant to the round put **Bowlum** (Billy Myers Jr.) up against **US Foods** (Gabriel Martinez) with Bowlum sitting 4 games up at 24-6 and needing just one win to take the round. US Foods game out huge, taking the first game by triple digits, but game two came down to the 10th frame, and two opens by US Foods matched up with one open and a spare from Bowlum sealed a 8-pin win to clinch the round. US Foods took a 3-2 win in the overall match. Kevin Jones led Bowlum with a 618 set while Paul Barraco paced US Foods with a 602 series.

The “B” match featured two teams mathematically eliminated at 18-12 with **Junior Amateur Tour** (Kevin Valmonte) taking on **Family Ties** (Bobby Campagnale). Again, the match was all Family Ties as they struck to a 5-0 sweep led by Bobby Campagnale’s 688 series. David Yamauchi led Junior Amateur Tour with a 618 set.

Threadworks (Eric Snow) was looking to get tough against **Don Julio Tequila** (Gabe Garza). Threadworks had their whole team back and started with a win, but it was all Don Julio Tequila as they cruised to a 4-1 win. Paul Varela led Threadworks with a 553 set while Gabe Garza was high for Don Julio Tequila with a 589 series.

Taco Bell (Kaven Massey) and **Weaverbird** (Eric Williams Jr.) were looking to bounce back and improve their 15-15 records. Weaverbird took the bookend games but a big 146-pin win in game two gave Taco Bell the 3-2 win. Mike Zuck was huge for Taco Bell with a 653 series while James Bael led Weaverbird with a solid 614 set.

DV8 (Matthew Zweig) was looking for their early round form taking on **Forest Lanes** (Jon Diso) who was coming off a big week. Forest Lanes continued their hot streak as they swept DV8 for five. Marshall Degnan was huge for Forest Lanes with a 662 series while Matt Zweig paced DV8 with a 640 set.

Pro Approach Cal Bowl (Austin Wasielewski), **Pro Approach Del Rio** (Augie Labrado Jr.), **Touchstone Homes** (Christian Eichelkraut), **Del Rio Lanes** (Michael Barnett), and the two round winners **Pro Approach Oak Tree** (Leonard Ruiz Jr.) and **Love Laundry** (Ramsey Basurto) rounded out the night’s action. Pro Approach Del Rio took 4 from Pro Approach Cal Bowl led by Augie Labrado Jr.’s nice 624 set. Super-sub Stephanie Zavala’s 625 set paced the Cal Bowl bunch. Del Rio Lanes took a 3-2 win over Touchstone Homes with Michael Barnett leading Del Rio with a 548 set and Terry Hatley putting up 529 for Touchstone Homes. In the battle of the round winners, Pro Approach Oak Tree took a 4-1 win over Love Laundry. Ramon Torres led Pro Approach Oak Tree with a 585 set while Vernon Adams paced Love Laundry with a 581 series.
