

MIKE PARKER – Bowling Aficionado and "The Most Interesting Bowler in The World"



The bowler from Nottingham Drive knows Bowling. Mike Parker is his name. He is a Bowling Aficionado. That's a guy who is very enthusiastic and knowledgeable about the sport of Bowling.

Mike Parker is as enthusiastic about the sport of Bowling as any Las Vegas Raider football fan is about a Derek Carr touchdown pass. Mike is a Bowling fan rooting for our sports success at every level.

Mike Parker knows Bowling. He is an expert with comprehensive and authoritative knowledge of our sport. He knows Bowling as an activity, a pastime and as a sport. Want to know Bowling history, ask Mike. Want to know Bowling trends and current preferences, ask Mike. Want to know about the Professional Bowling Tours (PBA and PWBA) and their competitors, ask Mike. Mike knows Bowling.

Bowling is a huge part of Mike Parker's life journey. He has been a bowler most of his life. Decades of competing. Since beginning as a bowler he has been a student of the sport. He studied every aspect of bowling form and function. His bowling accomplishments reflect his astute eye for the detail necessary for high scoring. His performance credentials include honor scores, league highs and high averages.

Mike Parker knows Bowling. He will tell you that Brooklyn's Tom Curtis is the "Father of Bowling" and the first President of the American Bowling Congress. That Miss Bertha Kern of St. Louis, Missouri was an early United States Bowling Champion and that the All American Trio bowling team managed by Sam Karpf won 81 consecutive matches while traveling throughout the United States in the years 1902 and 1903. The All American Trio team was undefeated with an 81-0 record. Never has there been a more dominant performance or better competitive record in American sports history. According to Mike the All American Trio bowling team should be recognized by the Bowling Hall of Fame and Museum as one of greatest teams in Bowling history. That accolade would be bestowed on the team if Mike Parker had his way.

"Mike Parker knows bowling". His enthusiasm for and extensive knowledge of our sport makes him a "Bowling Aficionado" and "The most interesting bowler in the world".

January from expired Recipient accounts. \$1.2 million set aside for the new SMART Pell Grant Match.

USBC's SMART Committee intends to maintain the annual earnings allocation at \$7 million or more through at least 2024, unless investment market conditions significantly change. This will allow SMART Providers and Recipients to plan on similar new funds from SMART for three years.

"The 2022 SMART allocation will immediately change the lives of young bowlers with nearly \$1,000 in new scholar-ship funds hitting every active SMART Recipient's account," USBC President Melissa McDaniel said. "With SMART's intention to maintain at least a \$7 million allocation, SMART Providers should aggressively use their unassigned funds with the confidence of consistent new funding in the years ahead. This also allows active Recipients to plan on similar bonus scholarships through 2024 as well."

The federal Pell Grant is a national program that helps students and families with the greatest financial need pay for college. The new SMART Pell Grant Match will maximize the power of this federal program for bowlers by matching it dollar for dollar. The SMART Pell Grant Match will be available to any student with at least one season of USBC Youth participation and two seasons of overall USBC membership. Students can request the SMART Pell Grant Match by visiting BOWL.com/SMART. Applications for the SMART Pell Grant Match will be accepted through the end of the year or until the \$1.2 million in funding is exhausted.

"The SMART Pell Grant Match provides a new and innovative way for USBC's SMART program to help students in financial need within our bowling community," said Frank Wilkinson, chair of the USBC SMART Committee. "We encourage everyone involved in USBC programming to help with awareness about this new grant. Our challenge will be reaching our former youth bowlers to let them know about this fantastic opportunity."

In 2021, the USBC Board of Directors approved a series of policy changes for SMART, designed to increase scholarship benefits for SMART Recipients. The new policy allocates a portion of investment gains to be awarded as new scholarships in SMART Recipient accounts.

Who Knew?

The Largest Bowling Center In The World Was Once In Hollywood

After completing the story on Miami Bowl in Chicago a few weeks ago, I received an interesting list from J.R. Schmidt entitled "America's Largest Bowling Alleys (1944)." The list was provided by the American Bowling Congress and was probably generated because 1944 was the year that Hudson Recreation, with 105 lanes, had ceased operations at their Philadelphia location.

What caught my eye was a bowling center in the number 7 position, Sunset Bowling Center in Hollywood, with a total of 52 lanes. Having grown up in California and spending a couple of years living in the San Fernando Valley while working for AMF, I was surprised that I had not heard of this particular pin palace.

A quick review of the internet revealed a couple of interesting summaries, the most notable by J.H. Graham, author of the Avery Shepard Detective Mystery Series. In her recap, Ms. Graham notes that Warner Brothers had been in the process of converting some of their older studios into a new recreation center for their employees and the public to enjoy.

The year was 1937, and Los Angeles Times film critic Philip Scheuer lamented that the studios where many of the first talking pictures were made, would be converted into a sports complex, housing a roller skating rink, badminton courts, and "the world's largest bowling center, with 52 lanes in a row."

Now for those of you that have been reading my column for the past few years, you're astutely aware that Detroit Recreation, with 88 lanes, was next in line to the title of the world's largest bowling center at that time (The Recreation Center in Baltimore, with 100 lanes, was not included in the list because it featured duckpins, rather than tenpins).

In fact, there were many locations that listed more lanes than Sunset, including State Fair Recreation, Detroit (70), Adams-Wabash Recreation, Chicago (64), Rogers Recreation, St. Louis (63), Great Lakes, Detroit (60), and Capitol Health Center, New York (56). While I'm familiar with the layout of both Detroit Recreation (88 lanes on four different floors), and State Fair Recreation, with two sections of lanes back-to-back, to make the best use of pin boys, I do not know the configuration of the others.

The only conclusion that I can draw from this claim by Sunset Bowling Center is that the lanes were featured in a continuous row, without interruption. But whatever the reason, Sunset was opened up on May 29th, 1937, with great acclaim. An advertisement in local newspapers announced a pre-opening charity show on that evening from 7:30PM to 9:30PM. It was rumored that Harold Lloyd, an avid bowler, had organized the event with a minimum of one movie star on each of the 52 lanes.

In order to confirm some of this newfound information, I called upon Bud Horn, my bowling historian friend for all things bowling in Los Angeles. "That was before my time," said Horn, a member of the USBC Bowling Hall of Fame. "I had heard about Sunset, but don't remember ever bowling there."

Through the course of my online investigation, I came upon a couple of other bowling centers in Hollywood during this time: Hollywood Recreation, which I had been aware of through my association with Rex Golobic, whose father opened the facility in 1935; and another location that was new to me, Art Linkletter's La Cienega Lanes, which opened in 1946. "We used to bowl pot games at La Cienega," recalls Horn. He went on to say that he believes that famed promoter Harry Grant ran Sunset before moving on to Victory Bowl, and finally Encino Bowl on Ventura Boulevard.

Sunset Bowling Center and the remainder of the Warner Brothers sports complex lasted until the spring of 1954, according to J.H. Graham, when the buildings were sold to Paramount's television station, KTLA. "In March 1955, Paramount began razing the older buildings on the back lot, including the famous Studio 1 that had housed

the badminton courts and the roller skating rink, to build KTLA's new studio." The neoclassical style bowling center, resembling the White House in design, was not demolished, and still remains at 5858 Sunset Boulevard.





DOWNEY, Calif. -- The final night of Round 3, and really, the scenarios were all over the place. Four teams entered the night with a realistic chance of qualifying for our season-ending rolloff. Family Ties needed just two points to clinch it. You know Cal Bowl wasn't going to make that easy. Cal Bowl, with four points, could force a roll-off if US Foods didn't sweep. Even better, if Cal Bowl got four points and DV8 were to sweep US Foods, there

would be a three-way roll-off. You're going to have to read on to find out what happened. We're going to go backwards this week and start from the bottom up to the top of the league. Really, fasten your seatbelts, ladies and gentlemen. Here we go!

WBPI (7) vs. TDI Refrigeration (7)

These two teams have got to be the best of friends with how many times they've seen each other this season. The scores weren't very high, but the match was quite competitive. Game 1 saw WBPI take a 590-585 five-pin victory. Game 2 flipped over to TDI Refrigeration, 630-621, and also a four-pin series lead. Game 3 showed more flip flopping, and WBPI took a 637-614 win for the game and totals for four points to go up to 11 points to finish Round 3. Adrian Pelayo shot 474 to lead WBPI. TDI Refrigeration finishes Round 3 with eight points behind Joe Ray, Jr.'s 506 series.

Professional Approach Pro Shop (12) vs. Bowling Guys (10) Bobby Campagnale had himself a night, and it was enough to sweep Professional Approach Pro Shop by 148 pins behind a 657 series (237, 235, 185). Also big for Bowling Guys was Ricardo Mendoza, who chimed in with a 618 series. Saul DeUlloa shot 234 in Game 3 to help seal the sweep for Bowling Guys. Bowling Guys finished the round with 15 points. Bryan Osborne led the way for Professional Approach Pro Shop with a 590 series.

California Timberline (14) vs. Team Hu\$tle (13)

Edward Estrada could not be held back in Game 1. He shot a 245 game, combining with Blayke Miller's 205 game for a 785-693 win for California Timberline. The lanes must have broken down quite ugly from there on because the scores fell harshly. Jello Gray shot a 188 to help Team Hu\$tle sneak a two-pin win (672-670) to even the set. Still, California Timberline held a 90-pin advantage heading into Game 3. The scores tumbled even more, and California Timberline would not let go of its advantage. Estrada led the team once again, shooting a 182 to complete a team-leading 599 series in a 651-609 win for California Timberline. California Timberline jumps up to 18 points to finish the round. Jamie Carrington's 524 series led the way for Team Hu\$tle, which finished Round 3 with 14 points.

Westminster Lanes (14) vs. Threadworks (14)

It was rough going for Westminster Lanes to start this match out, as Threadworks jumped out to a 766-652 win behind Kevin Jones' 214 game. Don't say Westminster Lanes can't fight, though; Three of its bowlers shot at least 202 in shooting 803 against Threadworks' 741 for a 62-pin win. Still, Threadworks held a 52-pin series lead. Eric Snow didn't want to let the night get away from Threadworks, and he shot a 196 game to finish off his consistent 575 set, leading his team to four points and 18 for the round. It was a 693-661 win for Threadworks. Jamie Ferry led the way for Westminster Lanes, which finished the round with 15 points.

Forest Lanes (17) vs. Junior Amateur Tour (16)

The pairings changed a little here, as Bowlium, the winners of Round 2, was moved into a matchup against the winners of Round 1, Forever Hope Foundation. We'll cover that matchup in a bit. So, Junior Amateur Tour, instead of playing Bowlium, would get a Valentine's Day date with Forest Lanes. Forest Lanes got eliminated from round contention a week ago, but overall points still matter for teams that do not win one of the four rounds. Game 1, down to the wire, and Forest Lanes pulls it out, 745-743. The Diso's got business taken care of. JT led Forest Lanes with a 217, while his Dad, Jon, shot a 212. D.A. Smith added a 214 game for Junior Amateur Tour. Game 2 remained competitive, but the tide turned in favor of Junior Amateur Tour, as Anthony Santos shot a 226 game to help Junior Amateur Tour win a 765-729 result and take the lead in totals. The Disos shot deuces once more in Game 3, but both Smith and David Yamauchi would shoot 222 games in a 779-758 win for Junior Amateur Tour. Smith led Junior Amateur Tour with a 599; but not far behind was Santos with a 598. Junior Amateur Tour finished Round 3 with 20 points. JT Diso shot 614 to lead Forest Lanes, which finishes the round with 18 points. Jon Diso added a 603.

Forever Hope Foundation \$ (22) vs. Bowlium \$\$ (16)

Let's jump up to the matchup between the two round winners. Unless things drastically change between tonight and the end of the league, Forever Hope Foundation is looking like as safe a bet as possible to be the top overall seed in the Brunswick Invitational roll-off. But there's still plenty of bowling left, and the winners of round two, Bowlium entered the night quoting Lee Corso, saying, "not so fast!" In Game 1, Ramsey Basurto's 224 kept Forever Hope Foundation's winning ways going with a 727-705 win. Bowlium didn't like that, though. Billy Myers, Jr. came out firing with a 235 game, backed up by Butch Jackson's 220 and Arnold Cheesman's 211, and Bowlium shot 810 to Forever Hope Foundation's 768 to take the game and momentum in the matchup. Joe Smith added a 214 score in the Game 2 loss. Momentum stood with Bowlium. and it earned a 748-673 win behind a consistent team effort led by Cheesman's 197. Cheesman shot 590 to lead the team as well. Bowlium finishes Round 3 with 20 points. Basurto had himself a night with a 648 set. Forever Hope Foundation will settle for one point, finishing the round with 23.

Co-Main Event: US Foods (19) vs. DV8 (18) and Family Ties (22) vs. Cal Bowl (19)

It all came down to this final night, and each of these four teams had a chance to win Round 3 and secure a spot in the roll-off.

Family Ties needed just two points to finish off the round as

What made this matchup all the more interesting was Leonard Ruiz, Jr. against Steve Gurrieri. The partnership that has brought home so many Brunswick Invitational championships could possibly decide Round 3.

Game 1, the defending champions, Cal Bowl came out firing. Three 200 games led by Leonard Ruiz, Jr.'s 213 game helped to fend off PWBA superstar Stephanie Zavala's 257 game in a 792-777 win for Cal Bowl.

There was hope across the way. Either US Foods or DV8 needed at least four points to stand a chance in forcing a roll-off, or perhaps winning the round outright depending on what happened. DV8 would strike first behind Markus Betts' 229 game in

DV8 had life. US Foods did as well. In fact, through one game, all four teams were still in contention.

Family Ties came out shooting hard and would have won Game 2 against any other team in the league. However, there's two teams that would outpoint them, and one of those teams was on the pair with them, as Cal Bowl was on a mission to make things interesting. Cal Bowl got a 255 game from Ramon Torres in an 834-814 win. Guerrieri added a 223 game for Family Ties.

It was beginning to look like Cal Bowl could seal the deal for itself outright.

Betts continued to be huge for DV8, shooting a 254 game, alongside Scott Smith's 227 game to put the league on notice that DV8 was a serious contender for the night. Remember the other team that would have beat Family Ties? You guessed it, it was DV8's 845-798 win, which eliminated US Foods from contention.

And then there were three. DV8 needed to finish up a sweep and hope that Cal Bowl would not sweep Family Ties; but also, that Family Ties wouldn't come back to win totals. Things got good.

The big names struggled for Family Ties in Game 3, and sub, Vince Duarte put Family Ties on his back, shooting a 215 game on a tough broken down pair for a narrow 689-668 win for Family Ties. Ruiz, Jr. added a 212 for Cal Bowl, and totals came down to just 14 pins. But Cal Bowl had done what it needed to do. Cal Bowl jumped to 23 points for the round with its four points, led by Ruiz, Jr.'s 628 series. Family Ties also finished the round with 23 points behind Zavala's 609 series.

Entering Game 3. DV8 knew that Cal Bowl and Family Ties had to finish in that very scenario. US Foods could play spoiler though, and it nearly did. But Kyle Duster's 205 game would lift DV8 to a seven-pin win and qualify it for a three-game roll-off after bowling! Betts finished the night with a league-leading 667 series as DV8 finished with a round-leading 23 points tying Familv Ties and Cal Bowl. US Foods, led by Gabriel Martinez's 586 series, finished Round 3 with 20 points.

Three-Team Roll-off: DV8 (23) vs. Family Ties (23) vs. Cal Bowl (23)

Totals was the name of the game here. The team with the most pinfall would lift itself into the roll-off at the end of the league.
