Belmonte Beats Simonsen to Win Third Consecutive PBA World Championship Title

Belmonte tops Simonsen 213-190 in title match of rescheduled FS1 Finals telecast for 13th major title

LAS VEGAS - In a match-up between two of the Go Bowling PBA Tour's premier two-handed players, Australian Jason Belmonte defeated Anthony Simonsen of Little Elm, Texas, 213-190, in the title match Sunday at the South Point Bowling Plaza to win his third consecutive PBA World Championship title while extending his alltime career-leading major win total to 13.

Bowling in front of an on-site finals audience that consisted of mainly PBA players, their family members and tournament officials held three days earlier

than originally scheduled, Belmonte also notched his 24th career PBA Tour title to take home the \$150,000 first prize.

The PBA modified plans for all of the Storm PBA World Series of Bowling XI finals telecasts in response to the coronavirus pandemic, moving the live FS1 World Championship telecast to Sunday from its original Wednesday (March 18) slot while also postponing all additional competition in the three animal pattern (lane condition) championships. LAS VEGAS – USBC has announced the Masters, Senior Queens and Convention have been postponed, while the USBC Open and Women's Championships will delay their starts until at least May 1.

The move comes amid the coronavirus crisis that has hit the nation and has canceled many sporting events across the country.

to complete all 56 games of qualifying and match play for the World Championship last week to advance to the finals.

As the top seed for the finals, Belmonte also added to his ever-growing list of accomplishments in PBA majors joining Hall of Famer Earl Anthony as the only players to win three consecutive World Championship titles. Anthony did it twice when the event was called the PBA National Championship ('73, '74, '75 and '81, '82 and 83). Belmonte, the five-time and reigning PBA Player of the Year, was also making a record fifth consecutive major telecast appearance and eight of the last nine.

What made the win extra special for Belmonte was that he won in front of his entire family for the first time.

"It was everything to have my family here to see this," said the 36-year-old Australian, whose wife Kimberly, son Hugo, and daughters Sylvie and Aria were in attendance to witness the victory. "They were a calming influence when I wasn't doing well and a great support structure overall. It was a dream to have them here to see this."

It was also Belmonte's second consecutive major title this season after winning the U.S. Open on Feb. 23 to join PBA Hall of Famer Mike Aulby as the only players to complete the PBA Tour's Super Slam, which is a title in all five PBA majors (PBA Tournament of Champions, U.S. Open, PBA Players Championship, USBC Masters and PBA World Championship). It was in the 2019 World Championship that Belmonte won his 11th major to surpass Hall of Famers Pete Weber and Earl Anthony on the all-time major titles list.

In the title match, the 23-year-old Simonsen, trying to become the youngest player to win three majors, got off to a bad start with two opens after leaving difficult splits. Belmonte was able to take advantage by stringing strikes from the third through seventh frames which gave him enough of a cushion to win the match.

"Going into the match it was all going to be about speed control," Belmonte said. "Keeping it slow and getting a good consistent release was the key. Anytime you can keep striking, keep a big lead and your opponent believes he has to strike out to win, that's when you can really keep the pressure on."

The World Championship was the fourth and final event of the season that offered a \$1 million bonus if the winning player bowled a 300 game in the title match.

"Obviously you can't ignore the money in a tournament like this but it's never been the motivating factor for me," Belmonte said. "It's always about the title because that's what people will remember when the history is written."

In the semifinal match, Simonsen, a seven-time tour winner beat No. 2 seed EJ Tackett of Bluffton, Indiana, 215-177, to advance to the title match. Tackett, the 2016 PBA Player of the Year, was trying for his third major and 14th career tour title.

In the second match, Simonsen defeated Canadian Francois Lavoie 224-204 to advance to the semifinal match. Lavoie, a four-time tour winner that includes two U.S. Open titles, was trying for his third major win.

The finals started with Lavoie, the No. 4 seed, beating three-time Team USA member and former National Amateur Champion No. 5 seed Chris Via of Springfield, Ohio, 269-258 to advance to the second match against Simonsen. Via, a two-time PBA Tour runner-up, finished fifth to match his best finish in a major which came in the recent U.S. Open.



Past Health Issues Made Stakes Higher For Lavoie

LAS VEGAS – While the health of players, families and staff was top of mind this week, for François Lavoie it was even more critical than most.

Lavoie, who finished fourth Sunday in the PBA World Championship, had lung surgery in 2014 that sidelined him and even kept him from getting on an airplane for nine months

Considering the coronavirus can cause respiratory infection, Lavoie said he has had to be extra careful, and if it were up to him, the event would not have continued into Sunday.

"The CDC and World Health Organization said there was cause for concern, so when organizations like that speak out, I think there's merit there," Lavoie said. "I think we should probably listen to them. If it was up to me, I probably wouldn't have bowled."

The PBA consulted with the five World Championship finalists Friday and determined the event would continue with the stepladder finals moved up to Sunday. The PBA post-poned the remaining events.

"The decision was made that the TV show was going to happen anyway," Lavoie said. "I stuck around, stayed in my room all day yesterday, didn't really try to do much."

Although he said he did feel pressured to compete, Lavoie took responsibility for the decision

"Ultimately the decision was mine," he said. "I essentially had to choose between finishing the tournament in fifth maybe or a chance at all the money on top. It was a great opportunity. Ultimately, I decided to stick around, be as safe as possible for the extra day I was going to be here and do my best on TV to make the best of a poor situation."

Lavoie did point out that he was pleased the PBA made adjustments to try to create a safe playing environment, including holding the finals without spectators.

"I think the PBA went to a lot of lengths to make sure the environment was as safe as possible for the players, staff and everyone who was going to be here," Lavoie said. "It definitely felt strange. It was a unique experience not bowling in front of a live audience, but in the end, I think we got through it. The main thing is for us to go home and try to be safe for a while."



THE START OF THE 2020 PWBA TOUR SEASON IS POSTPONED INDEFINITELY DUE TO HEALTH AND SAFETY CONCERNS RELATED TO COVID-19

On March 15, 2020, the Centers for Disease Control and Prevention (CDC) issued recommendations to postpone events for the next eight weeks.

The PWBA will evaluate adjustments to the 2020 PWBA Tour schedule after CDC regulations evolve to allow for competition to resume.

USBC will allow teams registered to compete from March 21 through April 30 to reschedule with new added dates in the summer. USBC said they will be contacting team captains with additional information.

As for the Professional Women's Bowling Association Tour, the USBC said an announcement of any changes would come no later than April 2.

primary driver of the changes Friday with international players potentially having difficulty getting back home had the events continued as scheduled.

The PBA said the three standard-title animal pattern events will be contested at a future date, although no details are available yet.

Next, the PBA must decide how this impacts the upcoming PBA Playoffs. With the three animal pattern events and the upcoming USBC Masters postponed, the schedule has been upended and the opportunity for players to earn points has been cut short.

The Playoffs are scheduled to get underway April 6 with the Round of 24, but the PBA has not announced any changes as of yet. It seems likely, however, that some sort of adjustment will need to be made, especially if disruptions to international travel remain in effect.

CABAZON - Earlene Edwards is the only female bowler to ever roll a certified perfect 300 game at Canyon Lanes. Her perfecto was rolled on April 22, 2014 on lanes 5 and 6. Her series for the day was 712. That three game series may also be the highest certified series rolled by a woman in the Center. The Center houses 24 lanes and has been open about a dozen years now.

Earlene used a Roto Grip Roto Cell bowling ball to roll the best game of her life. While the Roto Cell was used to roll her big score, it isn't her favorite bowling ball. Her favorite ball of all time is the Brunswick Danger Zone because of the way it reacts down lane. According to Earlene, the Danger Zone is the most reliable ball she has ever owned because it is the most predictable ball she has ever owned. That predictability and consistency was the key ingredient in Earlene's developing confidence in herself as a bowler. Earlene will be the first to tell you that confidence in herself and her equipment was the key to her bowling success.

According to Earlene you can only succeed if you believe you can succeed. When you lose confidence in yourself you will ultimately fail. There's something about confidence. Confidence is invisible, confidence is merely a feeling. However, confidence is the key ingredient for success. On her record setting day Earlene was confident.

Earlene has been bowling for 33 years. She started relatively late, when 40 years of age. It was curiosity they got her started. She would go into Town Square Lanes and watch people bowl. After hanging around for several weeks she was asked to join a league and the rest is history. Earlene has been bowling ever since. Earlene Edwards is and always has been a student of the sport. After 33 years of studying the sport and other bowlers, Earlene knows bowling. She is a self-taught bowler who learned by observation. She studies every bowler during league play and has spent hundreds of hours watching PBA and PWBA professional bowlers on television. She also spends hundreds of hours watching professional bowlers on YouTube. Earlene is living proof that knowledge is power and a instrument to be used if a bowler wishes to become a great bowler. Earlene has used the knowledge she has acquired through observation to become a great bowler

In some ways it could be said that Earlene is a scientist. A "BOWLING SCIENTIST". She applies the "SCIEN-TIFIC METHOD" to the sport of Bowling. She observes, she accumulates data, she analyzes that data and then comes to logical conclusions. 
