DEERONN BOOKER COMPLETES IMPROBABLE RUN TO WIN USBC MASTERS TITLE

LAS VEGAS, NV — DeeRonn Booker of Albuquerque, NM entered Sunday's championship round of the USBC Masters as the undefeated top seed. The relative unknown to those outside of the bowling community and devout The Price is Right fandom left Suncoast Bowling Center in Las Vegas a bowling celebrity and a PBA Tour major champion.

Booker defeated Patrick Dombrowski to win the 2024 USBC Masters, earning his first career PBA Tour title and the \$100,000 top prize.

"With the amount of work that I put in, I knew I was going to be here someday," Booker said. "I'm here now. I'm not going anywhere. I hope you guys can see me."

"It's just the perfect opportunity at the right time," Booker said. "I've worked really hard to get to this moment, learning the lanes, learning

the PBA, learning equipment, learning myself. I had a feeling that I was going to do well because I prepared myself physically, mentally and

emotionally. I was able to keep my emotions in check. I was able to embrace myself in the surroundings. I felt like I really prepared myself

for this and I couldn't be more excited."

Booker became the third Black player to win on the PBA Tour. All three, including five-

time champion George Branham III and Gary Faulkner Jr., won major championships.

"What this does is keep inspiring me to keep inspiring others to do this, to get here, to be here. When I get back home, come and see me. Let's do this together," Booker said. "There are people out there that need help, that want help, that want inspiration. This win is going to help inspire them. This win means I can continue to do this. I can continue to inspire. I can continue to coach. I can continue to bowl. I can continue to do everything that I want to do for everyone else."

Booker, who qualified tied for 58th of 465 players, went undefeated in continued on page 4

KINGPINS CLINCH POSTSEASON BERTH IN VEGAS

New Jersey sweeps Dallas, Waco upsets Las Vegas to close Round 10



The final Round 10 matches of the PBA Elite League presented by Snickers, televised from Suncoast Bowling Center in Las Vegas, took place on Saturday night.

The New Jersey KingPins dispatched the struggling Go Bowling Dallas Strikers in consecutive games, 196-195 and 242-201.

With the win, the KingPins moved to 7-3

and now hold a five-game advantage over Dallas and Waco with just four rounds remaining. Therefore, New Jersey — and the Portland Lumberjacks — have clinched a trip to the postseason, featuring the top six teams in the PBA Elite League.

The 7-3 Las Vegas High Rollers had already clinched a postseason berth, but fell to the Won-

ders on Saturday.

The High Rollers hoped to take a one-game lead over the KingPins and Lumberjacks for a postseason bye.

Instead, those three teams enter the final four rounds of the season in the three-way tie with just two playoff byes available.

Join Us To Celebrate The 2024 Hall of Fame Inductions Part 2

-Event To Be Held At Holiday Inn Ontario Airport- Saturday, June 1, 2024

Here are the final three inductees for this year's California USBC Hall of Fame Inductions, to take place on Saturday, June 1st, 2024, at the Holiday Inn Ontario Airport. Further details can be obtained by visiting calusbc.com.

Last week I mentioned a national Hall of Fame member, Bruce Pluckhahn, and his comment to me about joining any Hall of Fame being unlikely because of my frequent moves around the country. I couldn't find that note... I'll probably find it next week while looking for something different. But here's one that I did locate, regarding my move from American Recreation Centers in Sacramento, Calif., to Nationwide Bowling Corporation in Jersey City, New Jersey:

"Good to hear from you, Dave, and to know you've landed solidly on your feet. Congratulations! As you might suspect, I hardly ever see that fellow named Weber. AMF has him on the run almost constantly. Things are going well here. Had a great time writing about half of the BJ's 80th anniversary issue. Now must buckle down and finish my book on the history of bowling. One of these years...!"

I'm not sure if Bruce ever finished that book, but there are a couple of nice write-ups about him online at britannica.com and upi.com. Speaking of Dick Weber, as I often do, I'm reminded of a quote from him that I never really thought about until today. I recall Weber saying something to this effect: "Records are made to be broken, but they can never take a title away from you."

Those are good words for every young bowler to take to heart. Don't get lost in the numbers but go for titles. The scores being thrown today are like telephone numbers compared to the best scores in the history of the game from just 40 years ago. But as Mr. Weber says, they can't take the titles from you!

Now, without further ado, here are the remaining profiles for this year's inductees. The first two are presented by me, while BCM editor Bob Johnson has been so gracious as to submit some kind words about yours truly... for which I am so truly grateful.

Ty Dawson — Ty was born in Muskegon, Mich., in 1953. His family moved to the city of Riverside, Calif., in 1958. He began bowling at Tava Lanes at the age of 9, and his first 300 game was recorded in 1979, at Delrosa Lanes in San Bernardino. Dawson now has a total of 101-300's, one of the highest totals in the country.

Dawson's accomplishments in his 41 years as a USBC member are many, including 54-800 plus scores — the highest being an 844 in tournament action at Yosemite Lanes. He moved to Northern California in 1989, but that didn't stop his assault on league and tournament records. Here are a few of his major victories:

- 1998 State Open Scratch Champion (including a 300 game)
- 2017 Cal State Seniors All Events Champion
- 2019 USBC National Super Senior Champion
- USBC State Mixed Doubles Title with Nina Bennett
- (5) PBA Regional Titles
- (2) Santa Clara USBC Masters Titles
- (1) West Coast Senior Title
- Highest sanctioned league average - 238

Even with all of his personal achievements, Dawson, at age 71, finds his greatest joy in teaching others. The USBC Silver Certified Coach has students that have recorded 300's and 800's following his instruction. Ty and his wife of 20 years, Elizabeth, live in Sunnyvale.

Pam Pancoast — Pam is a native Californian, currently residing in Lomita. She started bowling at the age of 9 and has never looked back, averaging over 190 in her twenties and over 200 for the past 30+ years. Pam has always been athletic, enjoying many sports, including owning a horse for 24 years. She didn't start competitive bowling until her thirties and credits her husband, Jon, with her focus and success. "I would never have been as competitive in bowling were it not for my husband," said Pancoast.

Pam has rolled 25-300's in her career, one of the highest totals in the history of women's bowling. She was the first woman to record a 300 in the California Open Championships in 2000. She has 5-800 series with a high of 835 bowled during a WWPB event at Mission Hills when she bowled a record holding 1619 total for six games (269.8 average).

Pancoast has a USBC National Scratch Singles, International Golden Ladies, (5) WWPB, (1) PWBA Regional, a California State team and multiple city titles to her credit. She held the national high average of 204 on a sport shot condition in 2001-02 and was WWPB Bowler of the Year in 2000.

Dave Williams — Meritorious service? Are you aware that in 1975, Williams rolled six 300 games in an eight-month span — something that had never been done in sanctioned competition? Or that the next year he set a California full-season average record of 230 for 75 games (as a member of a five-bowler team)? Or that he won the All-America Youth Bowling Championship in 1970? The list of on-the-lanes accomplishments in Central Sonoma County B.A., Marin County B.A. and Petaluma B.A. goes on... and on.

Williams grew up in a junior program in which "Peanuts" comic strip creator Charles M. Schulz was a coach and contributed cartoons to the weekly "Ten Pin Tales" newsletter. Perhaps some of that creativity rubbed off, as Williams would go on to create or co-create 30 adult league, 55 youth league, 16 senior league, 38 tournament, 13 learn-to-bowl and many other programs for AMF Bowling Centers... and even more for American Recreation Centers that put California residents on the lanes and helped transform untold numbers of them into lifelong bowlers.

The number of league bowlers alone amounted to more than 100,000. Williams also developed youth scholarship programs for both AMF and ARC, as well as an intramural bowling program that was adapted by the California State University system. A prolific writer, Williams is a regular contributor to Bowling Center Management Magazine, the California Bowling News, and other bowling newspapers from coast to coast. Since 2017, he has been a weekly contributor to the California USBC Association's website via his "Dave's Corner" column. Meritorious service? You bet.

the 64-player, double-elimination bracket to earn the top seed of the five-player stepladder finals. Along the way, he beat two-time defending Masters champion Anthony Simonsen and throttled reigning PBA Player of the Year EJ Tackett by shooting 300 and 784 in the three-game total pinfall match.

"I was able to channel a level of myself that I didn't even know I had," Booker said. "Bowling against arguably one of the best bowlers to do this game, I said to myself, 'DeeRonn focus, but let's really focus.' I was able to be so focused that to be perfectly honest, it wasn't even about the 279 or 300. It was about focus and keeping myself in the moment. I can't miss against (EJ) because he can throw a nine-bagger at any moment."

Players advanced to the championship round through the 64-player, double-elimination match play bracket. Booker went undefeated, winning six consecutive three-game total pinfall matches to earn the top seed. Dombrowski went 5-1, falling to Booker in the seeding round match.

Jason Belmonte, Sam Cooley and Richie Teece all lost at various points in the bracket, but emerged from the elimination bracket to earn the final berths on the show.

EJ Tackett, who sought to make his sixth consecutive televised championship round, finished sixth.

In the title match, Booker took down Dombrowski, 217-177. Booker converted a 9-pin in the 10th frame, then needed just two pins to clinch the title.

The crowd, which included over two dozen of Booker's friends and family in attendance, chanted his name as he soaked in the life-changing, career-redefining moment.

Dombrowski reached the title match after escaping from a chaotic 198-193 semifinal against four-time Masters champion Belmonte. Dombrowski opened in the ninth frame, which meant Belmonte only needed a mark in the 10th frame to win the match. However, after failing to recalibrate after a distracting noise, Belmonte missed right and left an 8-10 split.

Belmonte won the battle of Australia in the previous match, besting Cooley 222-191. The Australians each started strong, but Cooley's pin carry faded in the second half of the game. Belmonte fired a ham-bone from the sixth through ninth frames while Cooley left and missed a 3-10 split in the ninth frame.

In the opening match, Cooley defeated England's Teece, 206-180. After an opening double, Teece threw just two more strikes and missed a 10-pin in the fifth frame.

The PBA Tour continues with the World Series of Bowling XV in Allen Park, Mich. Roth/Holman PBA Doubles Championship qualifying gets underway on Wednesday.

With the win, Booker earned an exemption into the WSOB and April's PBA Tournament of Champions.

"The next step is preparing myself for the next tournaments," Booker said. "(The Masters) is here and it's gone. Now let's work to prepare myself for the upcoming tournaments. Let's do two majors. Let's go back to back."

Jim Land Plans to Put Adversity Behind Him

WINNETKA – Jim Land has done some impressive stuff in his more than 70 years of bowling.

He's averaged more than 200 in league play, he's drilled a 289 game and he's bowled a near-700 series.

And this feat may be unprecedented: Jim has an uncanny knack for bowling triplicates (three games with the same score in one series). He bowled a 154 triplicate in November 2021, then bowled a 156 triplicate about two weeks later. Then in early 2022, Jim rattled off a 156 triplicate and a 158 triplicate.

Jim is now ready to claim a new milestone.

At 83, Jim says it's only a matter of time before he resumes bowling at Winnetka Bowl after suffering a stroke, which was followed by a heart attack two weeks later.

Weeks after his ordeal, Jim visited Winnetka Bowl several times during his convalescence. Jim looked the part of someone who had just emerged from an ordeal but he talked freely and confidently about the future even then.

Jim Land, you see, is a fighter.

"My mom quit bowling at 92," Jim said, "and she died at 94."

It's been about five months since those disabling events forced Jim off the lanes. But Jim remains as upbeat as when he was bowling.

"I love bowling and I want to go back," said Jim, definitely one of the most popular bowlers in the Fun-timers and 49'ers senior leagues at Winnetka Bowl.

Jim typically arrives early for his league and greets bowlers with a bellowing salutation whenever his colleagues show up.

"I like people and I like people who like me. Like my mother said, I never meet a stranger," said Jim, who bowls in the same league as his longtime partner, Barbara Sonnabend.

And he added: "I'll come back one of these days. I really will. I have four bowling balls now so I'll get back. I can hardly wait. I miss it a lot."

How much does he miss the game?

"How much is a lot?" he said, laughing. "I've been bowling my whole life."

Sonnabend says Jim has been getting stronger by the day and expects "he'll be ready by maybe the winter league."

As for the doctors' prognosis: "A lot of doctors have done all kinds of things [to me] and I'm as clean as a whistle. I have a long life left is what they say," Jim said.

Even in his 80s, Jim throws one of the fastest shots in his senior league. And Jim knows it.

So do the rest of the players in his league when this right-handed marksman splatters the pins with one of his thunderous pocket shots.

"I've got a pretty good slice when I put the ball down and crank it," said Jim, also a talented horseshoes player who installed his own horseshoes pit in his Woodland Hills yard.

As for all those triplicates he's compiled, Jim quipped: "That's what happens when you bowl a long time."

matches so we can get that bye, that's very important," KingPin co-manager Carolyn Dorin-Ballard said.

The Wonders earned their second televised win of the season, winning 224-212 and 211-184. Unfortunately for the defending Elias Cup champions, those are the teams' only wins of the season.

Tied with the 2-8 Wonders in the PBA Elite League cellar are the floundering Strikers, who fell two full games behind Lucky Strike L.A. X and a postseason berth.

Through 10 rounds, the Strikers boast the third best team average in the league; their opponents, however, average a whopping 226.10, nearly 10 pins more than the next highest team.

Bill O'Neill, who took responsibility for the Strikers' loss to Waco on Saturday, which he called their worst match of the season, said it feels like everything has gone against his team so far this season.

"We've bowled fairly well most of the season," O'Neill said. "We just haven't been able to get anything going. We've had a lot of big scores pulled against us and untimely breaks or bad shots and just just everything's going against us so far this season. We're killing ourselves right now."

"We're making some good shots, it's just the pins haven't fallen our way," Shawn Maldonado added. "And then if we are bowling well, our opponents are bowling better. They're just striking way more than us."

The PBA Elite League continues next week in Allen Park, Mich. Round 11 will take place April 3 at 6 p.m. Eastern on BowITV, then the entirety of Round 12 will be televised on April 6 and April 7.

With four rounds remaining, there is time for the Strikers and Wonders to make a last season charge. But time is running out.

"We're probably gonna need all the rest of the way to try to get in (the play-offs)," O'Neill said.


