O'Neill chose his DV8 Damn Good Verge Pearl to start with four out of five strikes to earn a one-pin lead halfway through. After Troup failed to convert the 3-10 split in the eighth frame, O'Neill had the opportunity to even the match and force a 9th and 10th

left back-to-back 10-pins then saw his first delivery in the 10th frame—on the dreaded left lane-slide to the right of the head pin leaving the 1-2-4-8. He chopped it.

Troup stepped up on the frame roll-off. But O'Neill right lane and struck on his first ball. The defending champion yelled, "Bang, bang come after my belt," as he escaped to advance,

## PBA REGIONAL TOUR RECAP: CHRIS WARREN WINS REGIONAL TITLE NO. 58, ONE BEHIND THE ALL-TIME LEADER

The Guaranteed Rate PBA Tour and the PBA50 Tour flip-flopped this month as the PBA wrapped up the national circuit while the Senior Tour maneuvered into their national tour. Over the past few days, the PBA hosted five regional events all over the U.S. and not just the continental 48. Florida, Indiana, Texas, Maryland, and Hawaii opened their doors to many bowlers looking to make a run to the Regional Players Invitational later this year.

#### **SOUTH REGION**

**PBA50 LEHIGH LANES OPEN** 

The PBA50 Lehigh Lanes Open in Lehigh Acres, Florida, set itself up as the perfect tune-up event for the first PBA50 National Tour stop of 2022 due to Lehigh Acres' proximity to Fort Myers. Sixty-seven bowlers entered the field, many of whom were ready to make a big run during the PBA50 Tour this summer. After being split into three different squads and bowling six games apiece, the top 22 bowlers moved on to bowl another four games in the Advancers Round on Saturday morning. After that, the top eight bowlers rolled eight more games of round-robin match play to cut the field in half for a stepladder.

When the dust settled, it wasn't particularly close for the final spot as Jeff Johnson finished in 5th at +299 and Gary Faulkner in 4th at +513. Faulkner dropped the first match to the three-seed Chris Warren 237-222, but the real fireworks came a bit later as the 57-time regional champ delivered a 300 in the semifinal match against Amleto Monacelli, who shot a 199. Warren couldn't launch back-to-back perfect games in the finals, but he did grab title 58 with a win over Paul Fleming, 211-185. Chris Warren now finds himself just one title behind the all-time lead of 59, held by Walter Ray Williams Jr.

After five advancers round games, the lead for Jones ballooned from 95 pins to a whopping 228. In match play, no doubts arose as the margin sat at 332 pins with just the position round to go. Jones rolled a 204 in his victory lap game to claim his first-ever regional title, \$2,300, and most importantly, the banner.

The first of two Hawaiian events wrapped up on Tuesday in Pearl City, and 70 bowlers gathered to compete at Leeward Bowl. Bowlers began early Tuesday morning for seven games, attempting to secure a spot in the top 16 for single-elimination match play later that day. Keith Odette led the way on the Billy Hardwick Pattern, going +159 with Wesley Low Jr. not far behind at +156. Odette won his first match over Shane Dagdag while Low Jr. drew a worthy opponent in Anthony Simonsen, who made the trip out to The Aloha State for the pair of events. Low ended up taking the match, winning two games to one, but the lefty lost in the next round while Odette lost in the quarterfinals also. In the semifinal matches, Jake Peters defeated Adam Ishman 205-174, while Tim Cagle II moved past Joe Lipan 219-171. Following an open in the first frame, Cagle II dominated the match, throwing the next eleven strikes to take home the win 279-219.

Players did not have much time to get acclimated in Indiana because of the one-day format, but they needed to figure something out quickly when they hit the lanes. The 41-foot Smith pattern pushed the field of 72 to their limits as the cut line for the top 16 ran at just a 205 average, while Jonathan Schalow qualified first with a 225 pace.

After a lunch break, those 16 bowlers came back for another eight games in a round-robin format. Seven matches later and just the position round to go, two bowlers emerged miles ahead of the field, with Tom Hess at +582 and Graham Fach at +532. Fach already held a title in his back pocket from the Clutch Lanes Central Open Doubles tournament earlier this year, while Hess fought for career regional title number 13. Fach, who ran the table in his first seven games of the day, needed to win the eighth and final game by at least 21 pins to bring home his second regional title and eighth overall. Hess never had a sub-200 during match play until the finale, where Fach got the best of him, 234-193.

Along with grabbing his second title of the season, the undefeated Fach added regional title number eight to his resume and 2,500 points to his Central standings placement.

In Towson, Maryland, over 100 entrants made their way to AMF Towson Lanes for an entertaining two-day format where the double-bye was in effect. After eight games to start, the top 16 came back on Sunday for single-elimination bracket play. The top four qualifiers received a double-bye, the 5th-8th qualifiers earned a regular bye, and the 9th-16th positions started the day with best 2 out of 3 matches.

The Marshall Holman pattern seemed to be a bit nicer to the players than the 41-foot Smith pattern in Indiana, as it took a 214 average here to advance to bracket play. Michael Sanghi, Paul Smith, John Furey, and Tim Foy Jr. all grabbed ahold of the four double-bye positions, but only Foy Jr. and Furey advanced to the semis when they stepped to the plate. In the semifinals, Foy Jr. lost a close battle to eight-seeded Cody Shoemaker 208-205, while Furey took down Louis Gaudio 250-211. In the winner-take-all finals, the Pennsylvania native Shoemaker clinched his first career title over Furey 195-179 and moved to the top of the East Region leaderboard.

## **BRAD ANGELO WINS FIRST PBA50 TITLE AT LIGHTNING STRIKES LANES OPEN**

FORT MYERS, Florida - After putting himself in eight match play appearances in 2021, Brad Angelo is now a champion on the PBA50 Tour.

The New York native is quickly following up his successful rookie season by defeating current PBA50 rookie Dino Castillo Thursday at the PBA50 Lightning Strikes Lanes Open.

Both players started out with doubles and 9-spare. Castillo put together a three-bagger to take the lead before leaving the 3-4-6-7 split on the left lane.

"That was the turning point in the match," Angelo said of Castillo's split. "It hit that friction spot that had developed in the previous game and took off. That is why I was playing the left lane quite a bit deeper and I had to be slower to get the ball in the pocket to where it would not flat-10."

Angelo initially thought Castillo was going to convert the split when the ball left his hand, but Castillo only got one pin to open up the match.

After leaving a weak 10-pin and a ringing 10-pin on the right lane, on which Angelo felt like "the rack was a little off," he decided to make a subtle move with his feet and his eyes, while also changing his hand a little bit to get better deflection through the pins to carry the 10-pin. Those moves resulted in six straight strikes and nine on his final ball to win, 258-203.

"For me, my bread and butter is to be able to roll it really slow and when I can do that I feel most comfortable," Angelo said. "It's great to be called a PBA50 champion."

Castillo, who was especially animated in his first match against Barnes, was a familiar sight to Angelo.

"I have bowled against Dino Castillo now for over 30 years and that is Dino Castillo's MO," Angelo said about his friend. "He throws his hands all over the place and looks like there is an earthquake every time he throws the ball, so I was fully prepared for all of that stuff. He bowled great."

In the first match, Walter Ray Williams Jr. defeated Jon Rakoski 269-267. Williams struggled to carry in match two as Chris Barnes started with eight in a row for the 279-188 win.

Match three between fellow Texans Barnes and Castillo included nine strikes by Castillo as he won, 279-245.





the first-time this year," Troup said after the win. "I found a little something in my physical game before the round of 16. Physically I feel like I am putting the pieces together quickly and I am ready to go defend my title."

As for that hiccup in his physical game, it was noticed in Troup's set-up he was rolling his shoulders over too early which "set me south from there forward," he said.

"I thought I was doing things right all year long working with my timing," he said. "Apparently, I was, it was just this shoulder thing. Now I can feel my bad shots versus before I was trying to feel my good ones."

In the second match, the inaugural winner of the PBA Playoffs, No. 5 Kris Prather took on No. 4 Dom Barrett, who was looking to make a push for consideration in the 2022 Chris Schenkel PBA Player of the Year conversation.

This was a rematch of the 2022 PBA Tournament of Champions where Barrett defeat No. 1 seed Prather to become one of just eight players to win the Triple Crown. But it also was a bit reminiscent of the 2022 PBA World Championship that Prather won last month.

Prather switched balls a couple of times on the tricky left lane searching for the right look, while he stuck with the Storm Dark Code on the right lane striking every time in game one, as he smoothly mastered the TV pair.

"I made ball changes on multiple strikes in a row," Prather said about the left lane. "I just didn't really like what I saw at the beginning. I was seeing my ball hook earlier than what I wanted. Basically what you saw at the World Championship is what I was doing here. I have been seeing the ball well pretty much the last month in a half."

Prather began with the front seven, while Barrett threw the last six strikes to lose, 279-248. They combined to throw 19 strikes.

"For me, it (Dark Code) is smooth enough where I can really use my hand and be aggressive with my moves and angle changes," he said. "I have a lot of trust in that ball, and I feel like I can pretty much throw it on anything and do anything with the Dark Code."

It was more of the same for game two, as they again combined to strike 19 times.

Barrett started 9-spare followed by seven straight strikes. Prather doubled, picked up a 10-pin and continued to strike.

They were tied at 219 in the eight frame. Barrett picked up a 10-pin in the ninth and finished first with a double and nine for 268.

Needing a strike and nine spare to win, Prather doubled and got nine for an impressive 278. "Whenever I get left like that, my shot repetition goes up as far as frequency of well executed shots and my speed control and hand at the bottom is very consistent," Prather said about his game. "If I can throw it as slow as I want and hit it as hard as I want at the bottom then more than likely I am going to be bowling pretty well. Just fortunate to walk out on top after 270, 270 and barely winning the second game."

Prather, who has won three tournaments each with a \$100,000 purse, threw 20 out of 24 strikes during the two-game match.


He will now face another \$100,000 man, Troup, in the semifinals at 1 p.m. ET Sun., May 8 on FOX Broadcast Channel.

The winner of the Kia PBA Playoffs will earn \$100,000, a PBA Tour title, and a WWE championship belt.

His ability to repeat shots at high speed and high Rev rates enabled Travis to seriously compete for a USBC Title, for a coveted "EAGLE". His ball REV Rate from the left side must be about 450 revolutions. That is in a class with PBA stars CHRIS BARNES, SEAN RASH, E.J. TACKETT and PETE WEBER.

Travis has been bowling for 11 years after starting at the age of 22. It was his friend **Jared Reynolds** who got him to visit Arlington Lanes in Riverside and the rest is history. From beginner to potential PBA star in a decade and days.

EMPIRE BOWL in Redlands is Travis's house now. He feels the lanes there are maintained better than most houses, giving him a better chance to score. He also likes the competition at Empire Bowl. So many good bowlers like CORKIE DEMAIO, KENNY DEMAIO, MICHAEL GRAY, ZACH JELLSEY, TOBY LEE, MICHAEL NAKUNZ and MIKE RICK to name a few. Travis attributes his latest improvement to the superior competition he faces at Empire Bowl.

Travis's current ball of choice is the Roto Grip UC3. The backend hitting power and continuous ball motion through the pins makes the UC3 a dangerous weapon in the hands of a talented bowler like Travis Hicks. I have a mental picture of the sound of Travis's ball hitting pins and it sounds something like "TIC,TIC,TIC BOOM". Travis's ball is a ticking time bomb!

Travis's motto is "hard work pays off". Hard work pays dividends. Hard work makes for better bowling. Hard work makes for a higher score. Travis's favorite professional bowler is JASON BELMONTE because Jason works hard on his game. Jason proves that hard work pays off

stamp whenever a roundtrip flight was completed at check-in (this was before the age of computer connectivity). "Ten roundtrips on the plane get you a free roundtrip on the house," said the brochure. One of the flights that I often booked with Southwest during my time at American Recreation Centers (ARC) was from Sacramento to Orange County's John Wayne Airport in Irvine. There were a couple of reasons for using John Wayne Airport, as opposed to Los Angeles International, Burbank or Long Beach: most of the ARC properties were reasonably close to the less congested Orange County airport, and if you booked a flight on Monday or Friday there was a good chance of receiving a free ticket if you were bumped by a politician headed to, or returning from Sacramento!

While I was checking in at the gate one day for an upcoming flight, I noticed that one of the stamps had missed the box and was overlapping another adjacent box that had already been stamped. I alerted the attendant to the stamping issue, but she said that there was nothing that she could do, and she stamped the box next to the one in question for my flight. As I was leaving the Sacramento Airport later that day, I asked one of the ticket agents if there was anything that she could do because it was somewhat obvious that one of the boxes had two stamps.

The agent was sympathetic to my concern and provided me with an address to send a complaint (once again, this was before the age of computer convenience and most of our transmissions were still handled by "snail mail"). Now I don't remember if I photocopied the original Company Card, or if the Southwest Airlines employee at the receiving end of my message believed by faith what I was saying; but within a few days I received an apology from the airline, along with two free tickets to any Southwest Airlines destination!

I continued using that Company Club brochure for many years as an introduction to customer service seminars, explaining to bowling center employees how Southwest Airlines had turned a negative experience into an unbelievably positive example. I'm sure that some managers cringed at the thought of empowering their staff with this type of decision-making ability, but still others welcomed the idea, to prevent an experience like the one that I had with front line employees at Southwest.

A quick visit to the Southwest Airlines website reveals that the Company Club is now Rapid Rewards. While the name of their frequent flyer club has changed, the vision of Southwest has remained the same: "To become the world's most loved, most efficient and most profitable airline." Under the News & Updates section the following message is posted: "On Monday (April 18, 2022), a federal judge issued a decision stating the federal mask mandate for public transportation, including on airlines and at airports, is no longer in effect."

As I journeyed around my little section of the world in New Jersey, signs of the face mask decision by federal judge Kathryn Mizelle were everywhere, with supermarkets, shopping malls, Starbucks and even Walmart posting signs saying that the unpopular masks were no longer necessary, but optional. I guess it's like a politician that once said (paraphrasing), "If you like your face mask, you can keep your face mask." For me, I follow a simple rule that if the store employees are required to wear the mask, then I will also wear the mask in that establishment.

Hopefully, we are on our way back to normalcy.



# 2022 PBA LEAGUE PRESENTED BY PABST BLUE RIBBON DRAFT TO BE HELD VIRTUALLY MAY 18

### Ten PBA League teams will fill out their rosters on Facebook Live

The 2022 PBA League presented by Pabst Blue Ribbon Draft will take place virtually on May 18 at 10 a.m. and will be streamed live to the PBA Facebook page. Hosted by PBA Tour commissioner Tom Clark and featuring all 10 PBA League managers, each team will fill out its roster from a pool of eligible players to compete for the Elias Cup in July in Portland, Maine.
