## A Local Blast From the Past: Anthony Sharpsteen's 888

MISSION HILLS – It's now been six months since Frank Chiodo crushed an 886 series, firing games of 288, 300 and 298 in Winnetka Bowl's star-studded Mixed Classic Handicap league.

Chiodo's masterpiece ranks as the second-highest series in L.A. history.

The highest?

That distinction goes to Anthony Sharpsteen, who's known as "Mr. 888," or as elite bowler Johnnie Englehart calls him: "Triple 8."

The monikers are a tribute to Sharpsteen's majestic performance on Jan. 25, 2011. He finished with scores of 289, 299 and 300 during competition in the

### Youth Development

ARLINGTON, Texas – International Bowling Campus Youth Development has set the dates and divisions for the 2021 Junior Gold Championships that will take place in Indianapolis.

The 2021 Junior Gold Championships will be held July 5-17, 2021. Indianapolis will extend its record for most times to host, as the 2021 event marks the event's sixth visit to the city.

With the maximum age for USBC Youth member-

ship changing to 18 with the start of the 2020-2021 season, the U20 division will take place during the first week of the event, breaking away the adult from the youth divisions. The U20 division will be for bowlers born between Aug. 1, 2000 and July 31, 2002.

The U18 division becomes the oldest division for USBC Youth bowlers, with the U18, U15 and U12 divisions hitting the lanes following the U20 competition

# Youth Sports Leaders Form PLAY Sports Coalition

Nearly 20 years have passed yet those iconic words from Nelson Mandela stand tall and today are the foundation PLAY Sports, a first-of-its-kind collaborative coalition among more than 400 community and national sports organizations and leaders, has been built on.

PLAY Sports, which stands for Promoting Local and Youth Sports, represents a united front to support young athletes, working families, coaches and volunteers across all 50 states, particularly those in underserved areas, through the COVID-19 pandemic and beyond.

The fragmented and grassroots nature of youth sports necessitated an industry Coalition to work cooperatively, and with the federal, state and local governments and agencies, to advocate for a collective survival and impactful re-

## The Gutter Ball That Was Heard Around the World

Del Ballard Jr. suffered a heartbreaking finish in the Fair Lanes Open tournament in 1991. It was one of the most memorable – and shocking – moments in PBA history.

BALTIMORE – Being a bowler is more than just knowing etiquette and the rules of the game and how to knock down pins.

It's also being aware of the sport's history.

For those unaware of one of the Professional Bowling Assn.'s most bi-

turn. Left to its own, youth sports families and organizations will struggle, and a return to play would at least be delayed, if not fail.

According to recent poll results shared by the Aspen Institute for Sports, nearly 60% of local sports leaders said their organizations will project to lose at least 50% of their revenue over the next year due to COVID-19. They

zarre and shocking moments almost 30 years ago, it's worth repeating.

### Let's set the scene:

**Date:** March 7, 1991.  
**Event:** PBA's Fair Lanes Open tournament in Baltimore.

The stepladder championship match pitted top-seeded Pete Weber against third-seeded Del Ballard Jr., both right-handers. Ballard advanced to the championship match with victories of 247-208 over Robert Lawrence and 257-223 over Norm Duke.

Weber led Ballard by six pins through five frames but failed to mark in the sixth, allowing Ballard to seize a 15-pin lead after seven frames. Weber then struck out and forced Ballard to nail the first two strikes and tally seven pins in the 10th frame.

Ballard, of North Richland Hills, Texas, coolly struck on his first two balls. "Oh, baby!" Ballard triumphantly exclaimed after his second strike.

"I've never seen Dale Ballard so charged up, so aggressive," one of the broadcasters said. "Seven pins is no gimme, and when we've seen players miss, they get seven pins or less. So, it's not over yet."

Those were prophetic words, indeed.

Ballard's last shot was trouble as soon as he released it. And he knew it.

The ball rolled shakily down the right side of the gutter before collapsing in the channel about three-quarters of the way down.

Final score: Weber 213, Ballard 207.

Weber immediately raised his hands in victory

before putting them behind his head in shock and sympathy for his opponent. The agony that was painted on Ballard's face said it all.

"I could have thrown it down the middle and hoped for seven. I wanted to be aggressive on the shot and just rushed it," said Ballard, adding that a shot down the middle had risk "because if you barely hit the head pin, you could only get five."

Ballard later said: "My adrenaline was flowing too fast. I just ran up there and threw it. I didn't take my time and use my head."

Weber said "I thought it was over when Del got the first two. I felt like I reached out and stole it from him."

Ballard, 27 at the time, won \$15,500. Weber, with his then-16th tour title, won

FloBowling will offer a first look at its latest documentary as part of a week that celebrates two-handed bowling.

The new film titled *Two Hands On History* will debut later this year and the first teaser will be shown on May 7 following a re-release of FloBowling's documentary

*Simonsen: Leave It Behind.*

Two Hands On History will chronicle the rise of competitive two-handed in the Professional Bowlers Association. It will prominently feature the first two-handed PBA Tour champions, **Jason Belmonte** and **Osku Palermaa**.

The teaser will be revealed immediately after the re-release of *Simonsen: Leave It Behind*, which tells the story of the tough upbringing and rise to stardom of Anthony Simonsen. The broadcast will begin at 7 p.m. Eastern on May 7.

To kick off the teaser of the new documentary, FloBowling will offer a week dedicated to two-handed bowling. The Salute To Two-Handed Bowling week starts Monday will feature various content around two-handers and rebroadcast the stepladders of events related to them.

On May 5 and May 6, there will be two full days of rebroadcasts for bowling fans to enjoy. The first day of rebroadcasts on May 5 will be dedicated to many of the early wins by two-handed bowlers.

The second day of rebroadcasts on May 6 will showcase seven shows where two-handers met for the title, three of which came in the 2020 season.

# PBA League Draft Announcement

The 2020 PBA League Draft will be held Sunday, May 17, at 7 pm ET, and presented virtually, live on FloBowling, the PBA announced today. The draft will be conducted remotely for the first time, with team managers making their selections from their home locations due to COVID-19.

The PBA League, established in 2013 by the Professional Bowlers Association, features 5-player teams of the top bowlers in the world. Competition is slated for July 20-23 in Portland, ME, at Bayside Bowl, with live coverage of the seeding round on FloBowling, July 20, and finals on FS1, July 21-23.

The League will be adding two expansion clubs this season, the Las Vegas High Rollers and the Brew City (Milwaukee) Ballers, bringing the the number of teams to 10.

The High Rollers, managed by PBA Hall of Famer Amleto Monacelli and Ballers, managed by fellow PBA Hall of Famer Marshall Holman, own the first selections (based on coin toss) and will fill out their full 5-player rosters at the draft.

The other eight teams, including defending champion Portland Lumberjacks, will make two selections during the serpentine draft to fill out their five player rosters. Each of the eight original teams (Portland, L.A. X, Dallas Strikers, NYC KingPins, Silver Lake Atom Splitters, Motown Muscle, Brooklyn Styles and Philadelphia Hitmen) have previously protected three players from their 2019 rosters (listed below).

Lumberjacks manager Tim Mack, by virtue of his team's Elias Cup winning performance in 2019, will select 10th in third round, and first in the 4th round.

To be eligible for the draft, players must be ranked in the top 75 from a rolling PBA points list of 2019 and 2020 events. Headlining the list of eligible players are PBA champions Sean Rash, Francois Lavoie, Dick Allen, Andrew Anderson, BJ Moore, Jake Peters, Thomas Larsen, Jason Sterner, Ryan Ciminelli, DJ Archer, Osku Palermaa, Andres Gomez, Richard Teece, Ronnie Russell, Matt Ogle, Matt Sanders, Graham Fach, Ryan Shafer and Chris Loschetter. (Full draft eligible list below).

The 2020 Draft was originally slated for March 15 at the site of the PBA World Series of Bowling in Las Vegas, but was postponed due to COVID-19.

PBA CEO Colie Edison and PBA Tour Commissioner Tom Clark made the announcement of the virtual draft today on [FloBowling](http://FloBowling.com).



**Draft order:**

First pick, for expansion teams Brew City or Las Vegas decided by coin toss to launch draft. Then, those two expansion teams will get first two rounds: For example (in scenario Las Vegas wins coin toss):

**Round 1:** 1. Las Vegas (if win coin toss). 2. Brew City.

**Round 2:** 1. Brew City. 2. Las Vegas.

Then, other teams join snake draft, in reverse order of finish in 2019, with expansion teams first.

Two rounds of full league draft will finalize existing team rosters.



calling on Congress to assist community organizations not helped by the CARES Act survive until it is safe to return to play. The youth sports industry, comprised almost entirely of volunteers, nonprofits and small businesses, risks a complete collapse. This is about saving volunteer-driven organizations, youth sports infrastructure, jobs, and ensuring that young people have access to sports in a safe environment and receive the physical, social, emotional and cognitive benefits organized sports provides.

A letter backed by each of the more than 400 Coalition members, which included the National Council of Youth Sports (NCYS), PeacePlayers, YMCA of the USA and multiple U.S. sports federations, was delivered on Monday to Senator Mitch McConnell, Majority Leader of the U.S. Senate, and Senator Charles Schumer, Minority Leader of the U.S. Senate. Among the asks of Congress for support were an \$8.5 billion economic stabilization fund for youth sports providers and the formation of a youth sports COVID-19 Task Force.


The economic losses suffered by this forced pause, while not unique to youth sports, applies to the program providers, particularly sports-based youth development programs serving at-risk youth from under-resourced communities, as well as event facility hosts and large numbers of employees and contractors who make sports possible. Priority consideration in the disbursement of these funds will be given to these programs supporting under-served communities such as girls and youth with disabilities.

This designated fund also would include reimbursement for lost expenses, including camps and clinics, funding for employee and contractual-related expenses needed to continue operations beyond the allowable period of the CARES Act and competition and event cancellations that are non-refundable or insurable due to the National Emergency nature of the cancellations.

Beyond immediate relief, PLAY Sports will also engage a diverse set of stakeholders to advocate for the comeback of youth and local sports, centered around values of placing athletes first, inclusivity, accessibility, accountability, and innovation.

The coalition strategy includes: supporting families playing and coaching again, recognizing the economic and psychological devastation of COVID-19 will impact how families invest time and resources in participation in sports; and a playbook for return to play, ensuring there are clear guidelines, protocols, training and professional development to support the return of youth sports that ensures safe and positive sports experiences.

PLAY Sports Coalition is being led by a volunteer steering committee consisting of representatives across the youth sports industry, including Wayne B. Moss (National Council on Youth Sports), Benita Fitzgerald Mosley (Laureus Sport for Good USA), Jon Butler (Pop Warner), Jeremy Goldberg (LeagueApps), Keri King (Triple Crown Sports), and Luke Zientz (Reigning Champs). Active Policy Solutions, led by Terri Lakowski, is serving as a special advisor to the Coalition and its Steering Committee.

tion. The age breakdowns for the other Junior Gold divisions are: U18 (Aug. 1, 2002-July 31, 2005); U15 (Aug. 1, 2005-July 31, 2008); U12 (Aug. 1, 2008 and later).

The Junior Gold qualifying season officially kicks off May 1, 2020 and will run until May 16, 2021. Competitors must have a Junior Gold membership, which costs \$10 for U12 competitors and \$30 for all other divisions, in addition to USBC Youth membership or, for U20 bowlers, adult membership.

Junior Gold coordinators also need to be aware that U20 qualifying events must be held separately, with only U20 competitors in the field. Qualifying events for U18, U15, and U12 divisions can be combined.

With many states remaining under COVID-19 restrictions, IBC Youth Development encourages local coordinators to follow local guidelines before hosting a qualifying event.

IBC Youth Development also set dates for the national youth events that will take place in Indianapolis in conjunction with the Junior Gold Championships.

The USA Bowling National Championships qualifying rounds will be held July 7-8 with the U12 and U15 title matches on July 11. Regional qualifying events will start in the fall.

The Bowling.com Youth Open Championships will take place July 7-9, 16-18 and 24-25. U18 will be the oldest division for the event.

The Survivor Tournament for the U20 division is set for July 9 with the Youth Survivor taking place July 16-17.

IBC Youth also will launch two Junior Gold technology projects for the Junior Gold program.

A new Junior Gold qualifier portal, launching next week, will allow tournament directors to submit their Junior Gold Qualifier applications, upload rules, and make deposits online prior to their event. After the event, directors will be able to go online to upload results, enter advancers and alternates, and pay any remaining balance. The online portal will eliminate the need to submit paper forms.

The Junior Gold membership portal, which will launch this summer, will allow athletes to go online to log in and purchase their Junior Gold membership. Youth bowlers will be notified when the portal is available.



Chiodo had a shot at tying Sharpsteen's score on his last shot of his third game but left the 4-7. "It was my only ball out of the pocket," Chiodo said.

Sharpsteen, a right-hander from the San Fernando Valley, insisted that he was not in a zone during his night for the ages. "I was just relaxed and having fun," said Sharpsteen, adding that he enjoyed animated conversations with players such as Rusty Bryant, one of his team's opponents that night.

When Sharpsteen struck in the fifth frame of the final game, he said he felt really comfortable.

"That's when I knew I had the 800. I was more relaxed," said Sharpsteen, who left only a 9-pin and two solid 7-pins that night.

Amazingly, it was Sharpsteen's first 800 series. His perfect game was his 11<sup>th</sup> at the time.

Sharpsteen's previous best series was a 797. In fact, he had recorded that mark four times. "Each time, I got a split on my fill ball," lamented Sharpsteen, who's powerful 888 avoided any chance he'd forever be known as "Mr. 797."

Sharpsteen was filling in as a substitute that night for Mario Fiumara and used an Ebonite Mission ball for his record series. That history-making ball has since come and gone, he said. "It was all cracked out," Sharpsteen said.

As luck would have it, Sharpsteen's team lost all three games that night. His team lost by one pin the first game, two pins the next game and one pin again in the finale.

Asked if becoming the first L.A.-area bowler to knock out a 900 series is his goal, he recently said it was.

But Sharpsteen, who is averaging well over 200, said he has a more important mission when he bowls.

"I just come down [to the lanes] to have fun," he said.

\$30,000. **Footnote:** Ballard rebounded a few weeks later by winning the Long Island Open championship. His misfortune in the Fair Lanes Open notwithstanding, Ballard was a top-caliber PBA performer.

In 1994, he became the 11th player in PBA history to win \$1 million in career earnings. That year Ballard enjoyed his most successful year on the tour, winning four titles. Overall, he won 13 PBA titles, all between 1987 and 1993.

He has been inducted into both the PBA and United States Bowling Congress Hall of Fame.



