## 2017 CALIFORNIA PEPSI YOUTH CHAMPIONSHIPS AWARDS \$50,000 IN SCHOLARSHIPS

The 2017 California Pepsi Youth Bowling Championships is one of the longest tournaments held with league-level qualifying competition in November and January; District Finals held in March at eight different locations over two different weekends and then those qualifiers enter the State Finals that were just held this past May. A total of 396 bowlers participated in the U8 & U10 Divisions and 1,613 participated in the U12, U15 & U20 Divisions. The first place finishers in the U8 & U10 Divisions at the

District Finals earned a FREE entry into the 2017 Youth State Championships to be held this July at Country Club Bowl in San Rafael and the first place finishers in the U12, U15 & U20 Divisions at the District Finals earned a \$50 scholarship plus a spot into the Semi-Finals of the Diddy Watts State Singles Challenge to be held at McHenry Bowl in Modesto August 12-13. Bowlers in the U8 & U10 Divisions would survive through two rounds of qualifying and three rounds of qualifying for the U12, U15 & U20

Divisions (all qualifying levels were based on scratch scores). 55 winners in the U8 & U10 Divisions will earn District Scratch Scholarships totaling \$8,005 and \$10,763 will be awarded in District Handicap Scholarships to 159 winners in all six divisions.

### Rocio Restrepo Wins First Title of 2017 at QubicaAMF PWBA Sonoma County Open

BATON ROUGE, LA — On a very demanding and grueling condition, Rocio Restrepo of Louisville, Ohio, earned her third Professional Women's Bowling Association Tour title after capturing the 2017 QubicaAMF PWBA Sonoma County Open.

Restrepo defeated Brandi Branka of Fairview Heights, Illinois, 203-168, for her first PWBA title of 2017. The stepladder finals aired nationally on CBS Sports Network.

One of the keys to overcoming the 40-foot lane condition was to fill frames, and Restrepo did just that on her way to the title.

While compiling just three strikes in the championship match, she avoided any miscues and filled every frame during the final.

Branka, who was making her TV debut, had two splits in the first three frames, which was more than enough for Restrepo to take advantage. An early double for Restrepo ultimately would prove to be the difference, along with some key observations during practice.

"I knew, no matter what, it was going to come down to making spares and keeping it clean, especially with the TV lights," said Restrepo, who qualified for

the season-ending Smithfield PWBA Tour Championship at Richmond International Raceway in Richmond, Virginia. "This pattern is so flat, and there wasn't a good spot to play on the lanes.

It came down to how everyone else played the lanes, along with the transition and how they developed. There wasn't a perfect place to play, but I did what I needed to do, and it means the world to take home this title because of those reasons."

Branka earned her spot in the finals by defeating Shannon Pluhowsky of continued on page 2

### Marshall Kent Wins PBA Xtra Frame Lubbock Sports Open Title

*Former PBA Rookie of the Year wins first PBA singles title in U.S. to top "youth movement" finale*

LUBBOCK, TX — In a duel of past PBA Rookies of the Year, Marshall Kent of Yakima, Wash., ended a personal quest for his first PBA singles title in the U.S. Sunday, defeating EJ Tackett of Huntington, Ind., 233-194, in the PBA Xtra Frame Lubbock Sports Open at South Plains Lanes Saturday.

Kent, who won his only previous PBA Tour singles title in Saudi Arabia in 2014, locked out Tackett with a string of six strikes to finish the title match after Tackett struggled until the ninth and 10th frames to throw two strikes in a row.

"I had a game plan going in to do what I did all week, which basically meant making moves to the left and making good shots," Kent said. "It looks like I made enough good shots down the stretch to get the job done.

"I'm still trying to process the win," he added. "It means the world. It's been a long time. It feels unbelievable. I haven't been bowling that well lately, so I spent 15 hours last week practicing, putting in the continued on page 8

LAS VEGAS — PBA's Xtra Frame will provide start-to-finish coverage of the Suncoast PBA Senior U.S. Open presented by Storm from Suncoast Bowling Center in Las Vegas. Coverage of qualifying squads will begin at approximately 7 a.m., 10:45 a.m., and 2:30 p.m. Monday, Tuesday and Wednesday followed by match play rounds at 8 a.m. and 1 p.m. on Thursday, June 15, and 7:30 and 12 p.m. on Friday, June 16. The stepladder finals will air at 3:45 p.m. on Friday.

PBA Tour coverage will feature the PBA Xtra Frame Lubbock Sports Open presented by Ebonite from South Plains Lanes in Lubbock, Texas, Saturday and Sunday. The fourth of seven PBA Xtra Frame Storm Cup events will include qualifying round coverage Saturday at 6:20 a.m. and 1:20 p.m., followed by the cashers round at 6:20 a.m. Sunday, match play at 10 a.m. and the stepladder finals at 1:45 p.m.

Dayton, Ohio, 211-197, in a match where each player filled all 10 frames. Pluhowsky led by one pin through four frames, but Branka delivered a pair of doubles down the stretch to take the advantage. Branka secured the victory with a spare in the final frame.

Pluhowsky, the only left-hander on the show, defeated Colombian native Maria Jose Rodriguez of Austin, Texas, 222-205, in the opening match, which featured the most combined strikes of the three matches with 14.

All qualifying and match-play rounds of the QubicaAMF PWBA Sonoma County Open were held at Double Decker Lanes in Rohnert Park, California, on April 28-29.

The stepladder finals were held May 23 at the Raising Cane's River Center in Baton Rouge, Louisiana, in conjunction with the USBC Queens and the finals of the PWBA Storm Sacramento Open and PWBA Fountain Valley Open.



# WHO'S NEXT? FANS TO SELECT WES MALOTT'S NEXT KING OF BOWLING OPPONENT

Who'll be the next player to challenge Wes Malott as "King of Bowling?" PBA fans are invited to help decide "who's got next" in trying to remove Malott's crown in the renewal of the PBA's exclusive Xtra Frame pay-per-view competition that will take place on Monday, June 26, at FireLake Bowling Center in Shawnee, Okla., preceding the start of PBA's Grand Casino Hotel & Resort Oklahoma Open.

Malott, who dominated the original King of Bowling series held at Kegel Training Center in Lake Wales, Fla., in 2009, successfully defended his throne – and kept his crown – when he won the revival of the competition on April 12 in Portland, Maine, defeating reigning PBA Player of the Year EJ Tackett and Australia's Jason Belmonte, PBA Player of the Year the three previous years, with a 721 series. Tackett had a 664 series and Belmonte a 640 in the three-game, total pinfall contest.

Malott, now 40, kept his streak alive in Portland eight years after dispatching Parker Bohn III, Chris Barnes, Patrick Allen, Walter Ray Williams Jr. and Rhino Page in five consecutive King of Bowling matches back in 2009 – the same year "Big Nasty" also was selected as PBA Player of the Year.

Fans will be asked to pick Malott's next challenger from among a roster of recent PBA Players of the Year, except for Tackett and Belmonte. Beginning Monday (June 12), fans are invited to visit [pba.com](http://pba.com) or PBA's Twitter account to vote for their choice of Tommy Jones (2006), Chris Barnes (2008), Walter Ray Williams Jr. (2010), Sean Rash (2012) or two-time PBA50 Player of the Year Pete Weber as Malott's opponent. Fan voting will close at 3 a.m. EDT (midnight PDT) on Friday, June 16).

The pay-per-view match will begin with a pre-game show at 7:40 p.m. EDT on Monday, June 26, with the match starting at 8 p.m. Fans can sign up to watch the match for \$2.99 on [xtraframe.tv](http://xtraframe.tv). All money generated from PPV fees will be awarded as prize money to the winning bowler.

## SPEAKING OF WES MALOTT...

Wes Malott finished fourth in the PBA Xtra Frame Greater Jonesboro Open Sunday in Jonesboro, Ark., but the most interesting story about Malott's participation in the tournament had to do with his 13-year-old son Jordan Malott finishing in a tie for 74th place in his first PBA tournament appearance.

"It's kinda funny," father Wes said. "I signed (Jordan) up and I didn't tell him. I don't think I even told my wife. He didn't know he was bowling until we were on the road and stopped to eat. He asked me why I brought his equipment along. He told me he didn't want to bowl, but he'd been hounding me about entering local events, so I signed him up."

"It was good for him; it got everyone talking."

Jordan Malott, Dad said, is already almost six feet tall. "He's wearing size 13 shoes, just like me."

Jordan will bowl in USBC's Junior Gold Championships in July. The past two years he finished in the fifth through eighth group in the U12 Division. This year he'll move up to U15 but "he'll hold his own," Dad said.

Regarding Jordan's experience in Jonesboro, Wes said, "He's used to winning, so he had a hard time. After three games, he was in third or fourth place. He beat me the first four games, I know that. But in games six and seven he shot 140s."

"He knows a lot of those guys," Wes continued. "He watches them on TV. He has a lot of respect for them, but I told him there's no reason to be afraid; just go out and bowl, and he did."

Now the problem in the Malott household, Wes said, is that middle son Camden is already asking when he'll get his turn. Camden turns 10 in August. And "Brooke is seven, but she's already showing signs, too." When or if Jordan will bowl in another PBA event is an unknown because now it's baseball season, Dad said, and "he's a very good baseball player, too."

# Private-Equity Firm Atairos Buys Bowlmor AMF for More Than \$1 Billion

Private-equity firm Atairos Group is paying more than \$1 billion for Bowlmor AMF, nearly four years after the world’s largest bowling-center operator exited bankruptcy protection, according to a person familiar with the matter.

The two companies announced the sale, without disclosing a purchase price, earlier this week.

Bowlmor AMF was created from the merger of bowling chains Bowlmor and AMF Bowling, which was in bankruptcy at the time. The company has \$577 million in debt on its books, according to its most recent earnings report.

The sale to Atairos represents a windfall for owners including Cerberus Capital Management, Credit Suisse and DG Capital, according to the person familiar with the matter.

Cerberus Capital and Credit Suisse obtained a 77.5% stake in AMF through their ownership of the company’s junior debt and by investing \$50 million in a rights offering.

Bowlmor AMF owns 304 bowling centers in the U.S., Mexico and Canada. It acquired Brunswick Corp.’s bowling centers in 2014 for \$270 million.

# ENGLAND’S DOM BARRETT RETAINS LEAD IN XTRA FRAME STORM CUP POINTS RACE

England’s Dom Barrett, with a ninth-place finish in the PBA Xtra Frame Greater Jonesboro Open after third- and fifth-place finishes in the first two, has retained his lead in the Xtra Frame Storm Cup points standings after three of the seven events.

Barrett earned 18 points in Tamarac, Fla.; 16 points in Wilmington, N.C., and 12 more in Jonesboro for a total of 46 points and a 12-point lead over EJ Tackett, who has finished third (18 points) and fifth (16) in the last two events. Reality Check Classic winner Josh Blanchard is third, one point behind Tackett.

In each Xtra Frame Storm Cup event, the top 20 players earn points toward a pool of \$50,000 in bonus prize money that will be awarded to the top five players at the end of the series. To date 41 players have earned points.

# Bill Lew Fires Up Another Family Milestone

WINNETKA – It’s been a real Lew-Lew of a season for one elite bowling family. On June 1, Bill Lew blasted his first sanctioned perfect game as part of a sizzling 728 series (300-201-227). Lew, a 68-year-old right-hander, recorded his gem three months after his son, Adam Lew, notched his second perfecto. Adam, 34, blistered his first 300 in December.

Not to be forgotten is Bill’s daughter, Amy, who has been on an absolute roll and is threatening to join the Lew perfecto club. Amy, 33, with her textbook form, recently blasted a 257 en route to winning her league’s women Sweepers title. Adam, incidentally, won his league’s men’s Sweepers championship.

So it was a clean Sweep for the Lew brother-and-sister combination.

But back to Bill’s masterpiece. Bill actually recorded his first perfect game in September at AMF Riverside Lanes. But the league was not sanctioned so he was still chasing his first official 300 when he found his 12-strike mark at Winnetka Bowl.

“I’m so proud of him,” Amy says. “He’s definitely an inspiration to become a better bowler. He works so hard on his game and his scores show it.”

Bill said nerves were not bothering him as he prepared for his final shot of his 300 in Winnetka Bowl’s Thirsty Nite Out League. “To be perfectly honest, I wasn’t nervous at all.

“I just knew that I had to roll a good shot and I did,” said Bill, who travels 78 miles one way from his Riverside home to bowl. “As a matter of fact, my kids know that – whenever there’s a time where I have to perform, that’s the moment I live for.

“With 40 to 50 people behind me supporting me, the last thing I wanted to hear was, ‘Awww, he pulled the shot.’ I had to make a good shot.”

The first person to congratulate him was Adam, who like Amy, was bowling on Bill’s team that night. “This [300] was better than the first one because my family was there,” said Bill, adding that the 300 was “one of the best moments of my life, ranking right up there with having my kids.”

Bill, likewise, was present when Adam knocked out his most recent 300. “The place all went nuts,” recalled Bill, whose wife, Nancy, averages 153. “It was tremendous. [My kids] are really well-liked so when Adam did it, the whole place swarmed him and I saw that. I was so happy for him when they all gave him hugs and handshakes.”

Now that the Lew family has reached another milestone, the spotlight shines on Amy. Bill says she’ll have her moment in the 300 sun too.

“Hopefully really soon,” Bill said. “The past few weeks she’s tightened her game a bit and is banging out some good games. I know she’ll shoot one.”

That wouldn’t come as a big surprise. Bowling 300s is a family affair for the Lews. Bowling excellence comes easily.

“It’s in their blood,” said Bill, whose dad was a scratch bowler. “They can’t help it.”

# Tackett, Svensson Earn No. 1 Berths for Main Event PBA Tour Finals Stepladder Rounds

ORLANDO, Fla. – Reigning PBA Player of the Year EJ Tackett of Huntington, Ind., and Sweden’s Jesper Svensson, two of the PBA’s rising 20-something stars, put themselves into prime position to advance to the championship round in the inaugural Main Event PBA Tour Finals at Main Event Entertainment Orlando.

The 24-year-old Tackett, with a 3-1 match play record and 1,144 pins including a 299 game, held off Ryan Ciminelli of Cheektowaga, N.Y., by 33 pins to earn the no. 1 berth in the Group Two stepladder finals that will air on CBS Sports Network on June 20 at 6:30 p.m. Ciminelli ended Tackett’s bid for an unbeaten record in match play with a 268-231 win in their position round, also finishing with a 3-1 record and 1,111 pins.

In his loss to Ciminelli in the final match, Tackett finally missed the pocket for the first time in four matches. A 4 pin cost him a 300 vs. Barrett in match three, but three single-pin spares plus a 2-4-8-10 split (which he failed to convert) led to his only loss, to Ciminelli, in position round.

Ciminelli looked back to his 227-200 loss to Tackett in his opening match, when he missed a 10 pin and left a 3-6-7-9 split as the reason he was unable to finish at the top of the Group Two pod.

“What killed me was following Jesper (on that pair),” Ciminelli said. “I left easy spares, but the easy spares are the ones you miss when you’re busy thinking about what you need to do. That really caught me. I had a good look in practice, but all of a sudden they got really tight down-lane and it caught me off guard. We don’t have a lot of tournament games in this format so you don’t see the transition, and that’s really what ended up costing me the lead.”

England’s Dom Barrett qualified third in Group Two with a 1-3 match play record and 999 total pins, relegating Tommy Jones of Simpsonville, S.C. (1-3, 965 pins) to fourth place in their Group. Barrett and Jones will bowl the opening match in the Group Two stepladder finals, with Ciminelli taking on the winner and Tackett awaiting the survivor of that match for the two-game, total pinfall finale.

Svensson, 22, continued to dominate Group One, defeating Australia’s Jason Belmonte, 279-258, after winning his first two matches with 268 games. But Sean Rash of Montgomery, Ill., ended the Swedish two-hander’s bid for an unbeaten record, 234-222, in their position round match. Svensson still won the group with a 3-1 record and 1,187 pins.

With his position round win that included 50 bonus pins, Rash claimed the no. 2 berth for the Group One stepladder finals, airing on CBS Sports Network on June 13 at 9:30 p.m. EDT, with a 3-1 record and 1,062 pins. Belmonte, no. 3 with a 1-3 record and 988 total pins, will bowl the opening match against no. 4 Anthony Simonsen of Austin, Texas, who finished with a 1-3 record and 940 pins. Simonsen avoided a winless match play record and helped derail Belmonte’s bid for the no. 2 berth, winning their position round showdown, 259-245.

Belmonte, who came into the PBA Tour Finals as the earnings leader over the 30-month span, said he tried a variety of approaches – urethane and reactive balls, outside and inside angles to the pocket, less speed and more speed – to develop a game plan for the Group One stepladder finals and, hopefully, the championship round.

“I wasn’t sure anyone was going to shoot under 220,” he said after his four matches, “but you also have to think long-term. If I could beat Anthony and beat Sean, I’d still had to beat Jesper (in the two-game stepladder finale) and I needed a good ball reaction if I was going to keep going. So that’s why I ended up going back to reactive.”

The stepladder rounds will be pivotal in determining who wins the inaugural Main Event PBA Tour Finals, along with its \$30,000 top prize and PBA Tour title. The winners of the Group One and Group Two stepladder events will bowl for the PBA Tour finals in a three-game, total pinfall match that will air on CBS Sports Network on June 27 at 9:30 p.m. EDT. The stepladder runners-up will bowl a one-game preliminary match on the final show to determine third and fourth place finishes in the event.

extra time to get ready.”

The Lubbock Sports Open were a showcase for the PBA’s youth movement. Tackett, PBA’s reigning Player of the Year and Lubbock’s top qualifier, was the oldest of three 24-year-olds in the stepladder field, just a few weeks older than Kent and fourth-place finisher AJ Johnson of Oswego, Ill. Third-place finisher Jakob Butturff of Tempe, Ariz., is 23. Tackett was PBA’s 2013 Rookie of the Year; Kent won that honor in 2014.

Kent kicked off the four-man stepladder finals with a string of six strikes on his way to a 259-228 victory over Johnson. He then took advantage of Butturff’s inability to carry strikes early in the semifinal match, posting a 222-217 victory to advance to the title match against Tackett, who helped Kent win his second PBA Tour title as Merica Rooster Illusion teammates in winning the PBA Team Challenge in Las Vegas last fall.

Butturff, the defending champion and the only left-hander among the top 16, made a big move during the six-game cashers round, averaging 259.5 behind games of 259, 258, 258, 234, 259 and 289 to charge out of 11th place into the lead heading into the eight-game match play round. The Tempe, Ariz., resident held the lead until his final position round match where he lost to Tackett, 228-165, dropping to second place for the stepladder finals and eventually finishing third.

With his second-place finish, Tackett took the lead in the Xtra Frame Storm Cup points race, picking up 19 points for a 53-point total to move ahead of previous leader Dom Barrett of England who finished in a tie for 28th, failing to add to his 46-point total. Lubbock was the fourth event in the seven-tournament Xtra Frame Storm Cup series that will reward the top five points leaders with shares of a \$50,000 bonus prize pool.

After a 13-day break, PBA’s 2017 Xtra Frame Tour continues June 24-25 with the “throwback” PBA Xtra Frame Billy Hardwick Memorial Open at Billy Hardwick’s All Star Lanes in Memphis, Tenn. The tournament will allow each player to use only two limited-technology polyester plastic balls, more in the tradition of technology used by the late PBA Hall of Famer during the early years of the PBA. All of the Memphis action will be streamed live on PBA’s Xtra Frame online bowling channel. Three-day, 30-day and annual subscription packages are available. of all, we will receive a percentage from each shirt sales that went directly into this year’s scholarship fund. The State Finals were held at Classic Bowl on May 6-7. Bowlers in the U12, U15 & U20 divisions qualified to this level based on a ratio of 1:5 from District to State. We had 301 bowlers travel from across the state to attend and bowl in six game blocks. 33 of these bowlers will earn Scratch Scholarships totaling \$26,932.

We also ran an optional Handicap Division, in which 190 bowlers participated and we will pay out \$1,900 to 19 bowlers.

  4. The tournament shall be conducted on a handicap basis – **90% of 210**.
  5. Bowlers need not belong to a senior league to be eligible for entry in this tournament.
  6. Entrants may enter only once.
  7. **The entering average shall be determined by the following priorities from an established SLACUSBC League:**
    - a. Highest USBC 2016 certified league average (minimum of 21 games). If none,
    - b. Highest USBC 2015 certified league average (minimum of 21 games). If none,
    - c. Highest USBC certified league-ending **SUMMER 2017** average (minimum of 21 games). If none,
    - d. Assigned average: Women 165; Men 175.
- Bowlers are responsible for verifying their own averages. Any falsification of the highest known average will result in immediate and final disqualification. If a certified “sport” league average is the bowler’s only average, then it will be adjusted per the chart in the USBC Rulebook to determine the correct entering average. Failure to use the correct average shall disqualify score if submitted average is lower than correct average thereby resulting in more handicaps. Prize winning will be based on the submitted average if it is higher than the correct average.
8. USBC rules 319a2 (10 pin increase in average), 319d (reporting of prize winnings) and 319e (15 pin increase in accumulated tournament average) will be waived.
  9. Replacements for original entrants may be made providing the replacement meets eligibility and average requirements per Rule 7. A replacement must bowl under their own name at the time the event is scheduled.
  10. **Tournament dates:** July 29 and July 30, 2017. **Closing date:** July 26, 2017.

  15. **Winners in each age classification are eligible to participate in the 2018 USBC Senior State Championships.** Participation fees will be paid by SLACUSBC. The combined total of 6 games plus handicap will determine the champions. In the event of a tie for first place in any division, and since only one is eligible to participate in the State Seniors Tournament, the tie will be broken by using the highest 3 game series with handicap (i.e., first 3 game set or second 3 game set). If a tie still exists, the tie will be broken by using highest game with handicap. Arrangements will be made with each athlete within stated guidelines and parameters from the SLACUSBC for attending the State Finals. Eligible advancers must agree to bowl in the National Finals or, failing to do so, agree to waive all rights.
  16. In the event a winner of any division is unable or declines to attend the state tournament, the second, third or fourth place finisher from that division (in order of finish) will be eligible to compete.
  17. Bowlers must check in 45 minutes prior to scheduled squad time and must show proof of membership by showing their USBC membership card, a duplicate membership card printout from [www.bowl.com](http://www.bowl.com) or a letter of verification from the local USBC association.
  18. Bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. Frames may not be made-up. Bowlers not present to bowl when it’s their turn will be credited with a zero for that frame.
  19. In the event a bowler cannot finish their series, zero points will be scored the remaining frames.
  20. This tournament will be certified by USBC.
  21. The tournament director shall be the authority to interpret USBC and tournament rules, policies and procedures in deciding disputes. If deemed necessary, the tournament director shall consult with the board of directors of the SLACUSBC.
