## Norway's Torgersen Defeats Finland's Koivuniemi to Win Suncoast PBA Senior U.S. Open

LAS VEGAS – Tore Torgersen of Norway, a highly-decorated bowler on the international stage, thwarted PBA Hall of Famer Mika Koivuniemi's bid for a second consecutive Suncoast PBA Senior U.S. Open presented by Storm title Friday by winning the low-scoring title match 184-178 at the Suncoast Bowling Center.

In a title match where strikes were hard to come by, the 50-year-old Torgersen, bowling as a non-PBA member, was able to take an early lead in the match when Finland native Koivuniemi, who was top qualifier for the stepladder finals for the second consecutive year, failed to convert the 1-2-10 washout in the fourth frame. Torg-

ersen missed a 10 pin in the seventh frame, but the 52-year-old Koivuniemi, who won last year's Senior U.S. Open for his first

PBA50 Tour title, couldn't take advantage of the opportunity giving the win in the season's third and final major for players 50 and

over to the Norwegian.

"I made the mistake about thinking about the 10 pin," said Torgersen, the 2000 World Amateur

Bowler of the Year and a member of the World Bowling Writers Hall of Fame. "I was thinking that I hadn't missed a 10 pin in

a while, no problem – and what happened? I missed it. I was very fortunate to get away with winning after missing that."

Torgersen joined 2007 Senior U.S. Open winner Rick Minier as the only non-members to win the major.

Torgersen, who lists the 1994 Qubica/AMF World Cup title and the 1999 World Championships all-events gold medal among his many accomplishments in international competition, qualified second for the stepladder finals.

In the semifinal match he beat No. 3 qualifier PBA Hall of Famer Norm Duke who was trying for his second Senior U.S. Open win and sixth career PBA50 continued on page 5

### Sandra Andersson Wins First Career Title at 2019 PWBA Fountain Valley Open

*Local Favorite Missy Parkin Finishes Fourth*

FOUNTAIN VALLEY – Sweden's Sandra Andersson won her first career Professional Women's Bowling Association Tour title Saturday in a stunning title match at the 2019 PWBA Fountain Valley Open.

The back-and-forth finale at Fountain Bowl came down to the final shot as Bryanna Coté of Red Rock, Arizona, was unable to strike on her fill ball to force a tie, leaving an 8 pin to allow Andersson to claim a 184-183 victory and \$10,000 top prize.

"This means so much," said Andersson, who earned the top overall seed

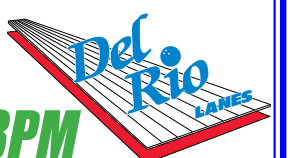

The 2019 California Pepsi Youth Bowling Championships is one of the longest tournaments held with league-level qualifying competition in November and January; District Finals held in March at eight different locations over two different weekends and then those qualifiers enter the State Finals that were just held this past May.

A total of 363 bowlers participated in the U8 & U10 Divisions and earned a FREE entry into the 2019 Youth State Championships to be held this July at Tyme to Bowl Lanes in Oroville. 1,466 participated in the U12, U15, U17 & U20 Divisions. Those 64 first place finishers earned a \$50 scholarship plus a spot into the Semi-Finals of the Diddy Watts State Singles Challenge to be held at McHenry Bowl in Modesto August 10-11. Bowlers in the U8 & U10 Divisions would survive through two rounds of qualifying and three rounds of qualifying for the U12, U15 & U20 Divisions (all qualifying levels were based on scratch scores). 42 winners in the U8 & U10 Divisions will earn District Scratch Scholarships totaling \$7,317 and \$10,315 will be awarded in District Handicap Scholarships to 153 winners in all eight divisions.

The State Finals were held at Double Decker Lanes in Rohnert Park on May 4-5. Bowlers in the U12, U15, U17 & U20 divisions qualified to this level based on a ratio of 1:5 from District to State. We had 249 bowlers travel from across the state to attend and bowl in six game blocks. 26 of these bowlers will earn Scratch Scholarships totaling \$21,848. We also ran an optional Handicap Division, in which 156 bowlers participated and we will pay out \$1,560 to 16 bowlers. Eight bowlers earned the FREE berths into the USBC Junior Gold Finals in Detroit, MI this July. Fireside Lanes; **Matthew Sartoris**, Cloverleaf Bowl and **Megan Ober**, Harley's Simi Bowl. Each of our eight champions will receive a travel stipend up to \$400 for the Gold Finals along with their state scholarship and a custom embroidered jacket. All scholarship recipients will receive a scholarship packet and all funds will be held with USBC SMART. We will be distributing the scholarship packets at the California USBC Convention in Ontario on June 8-9 and will mail the remaining packets directly to each bowler. # The Stuff That Legends Are Made Of... Leanne Hulsenberg Personifies All That Is Right In Bowling

It's easy to quantify exactly what makes Leanne Hulsenberg a legend in the game of bowling and in life. We are accustomed to associating success with numbers in bowling, and what she has done in her lifetime reads like a who's who in the annals of the Professional Women's Bowling Association (PWBA).

At the tender age of 19, she embarked on a professional career that included three victories in her very first year, and the subsequent Rookie of the Year honors. She followed that up with a total of 7 titles in her first three years, and 16 championships in ten years. At last count she had amassed 27 titles in a career that was shortened by the dissolution of the PWBA in 2003.

Leanne has also garnered other major accomplishments along the way that have made her the consummate female professional, rivaling the likes of male and female greats like Walter Ray Williams Jr., Dick Weber, Liz Johnson, and the legendary Marion Ladewig.

Yes, she is that good!

Along with all those PWBA victories, Hulsenberg has also made more than 100 television appearances, been named to the Bowlers Journal All-American Team a record 12 times, has five United States Bowling Congress (USBC) Women's Championships, was voted PWBA Player of the Year on three different occasions, and was recipient of the PWBA's Sportsmanship Award on two occasions.

What's really so astonishing about Leanne's career is that when the PWBA ceased operations in 2003, she was only 36, and in the prime of her bowling years. Projecting her average of 1.8 championships per year from her first 16 years, that would place her at 56 titles today.

She's also one of only three women to earn over \$1,000,000 on tour, and if you project her yearly average of \$62,500 from her fist 16 years, that would place her at over \$2,000,000 today. Considering the fact that the women do not compete in as many events as the men, nor do they vie for the larger purses afforded the men's tour, you can begin to see why it's so easy to quantify Leanne as a bowling legend.

Now we get to the stuff that legends are made of...

As if it wasn't enough to be inducted into the PWBA Hall of Fame on the evening of Wednesday, May 15th, 2019, Leanne started off the day by rolling in the Doubles and Singles events of the USBC Women's Championships at Northrock Lanes in Wichita.

She began slowly in the Doubles with a 188, before connecting for the fourth 300 game of the 2019 tournament. She continued with a 259 tally in game three for a 747 series. Leanne added sets of 707 in the Singles and 689 in the Team event, for a commendable 2143 All Events total.

Mr. Williams:

## PBA'S MERMAID LANES MIDWEST OPEN FEATURES A BIZARRE ENDING

Brady Stearns of Saint Augusta, Minn., won his first PBA Regional title Sunday in Mounds View, Minn., in what might have been the most bizarre ending in PBA Regional tournament history.

In Sunday's PBA Mermaid Lanes Midwest Open presented by Columbia 300 in Mounds View, Stearns defeated Nick Pate of Inver Grove Heights, Minn., 240-239, to win the title and \$2,500 first prize after Pate, needing two pins on his fill ball after converting a 10 pin spare in the 10th frame, saw his final shot drift right into the gutter.

Ironically, Stearns had opened the door for Pate in similar fashion just moments earlier. Working on a string of six strikes including the first two in his 10th frame, Stearns also threw his final shot into the gutter to give Pate an easier chance to win. Had Stearns struck on his fill ball, he would have forced Pate to also strike on his first shot in the 10th for the title, but his gutterball meant Pate only had to spare and get two pins.

Adding to the irony, the Mermaid Lanes Midwest Open was contested on the Del Ballard Jr. lane oiling pattern. The lane conditioning pattern was named in honor of the PBA Hall of Famer who infamously rolled a gutter ball on his final shot to lose the 1991 PBA Fair Lanes Open title to Pete Weber.

"It was the most bizarre finish I've ever seen, and I've been involved with the PBA since 1976 - 43 years. And I bowled a few years before that," said veteran PBA East Region Manager Russ Mills, who served as tournament director for the event. "I thought Nick was going to throw it right down the middle, but he didn't. I don't think he was aware of the situation, but hopefully he'll learn from it."

Prior to the climactic title match, Pate defeated Russ Oviatt of Chandler, Ariz., 279-236, to advance to the championship match after Pate downed Kiho Kyun of Plymouth, Minn., 257-219, in the first stepladder match.

In Saturday's PBA River City Extreme Midwest Open presented by Hammer in Monticello, Minn., non-PBA member John Kreyer Jr. of Mounds View defeated Stearns, 213-202, to win in Monticello. Kreyer earned \$2,500 but doesn't get credited with a PBA regional title since he is a non-member.

Kreyer defeated Mike Fagan of Las Vegas, 209-179, to advance to the championship match after Kreyer edged Blake Demore of Springfield, Mo., 214-212, in the first stepladder match.

# The Best Bowling Trio Ever: The Threesome of Petraglia, Schmitzer & Yeager

LAS VEGAS – When in the “Bowling Capital of The World”, for this years USBC National Convention, I visited the South Point Bowling Center. I wanted to pay a visit to old friend Jimmy Schmitzer. We were friends back in California when he rolled his certified 900 series and I hadn’t seen him or his parents, Jim Sr. and Marti, for at least six months. I wanted to catch up on the latest family news and see how Jimmy was bowling. The Schmitzer family are among the nicest people I have known in my lifetime.

I found the Schmitzer clan on lanes 53 and 54 with Jimmy bowling with John Petraglia Jr. and Steve Yeager. This awesome threesome is competing in the Storm Almost Scratch Trio League. I believe these three young men form the best league trio team I have ever watched bowl.

Why is this trio the best I’ve ever seen?

First, it is the only trio I’ve watched with every team member averaging over 230. That also means the team pretty much rolls a scratch 700 game every game they bowl! In over 60 years of bowling I have never seen another trio with three such bowlers.

My second reason for picking these guys as the best trio I’ve seen is PEDIGREE. They all come from a family of bowlers.

My friend and leadoff bowler Jimmy Schmitzer come from a family of bowlers. Jimmy is the author of one of the few certified 900 series in USBC history. He is a two hander who regularly rotates a bowling ball over 500 revolutions. He is the ideal lead off bowler because he is consistent, he strikes a lot but also makes his spares when he doesn’t strike.

When speaking of PEDIGREE what more can be said then having Johnny Petraglia Jr. as your anchorman. John is the son of all time PBA great Johnny Petraglia. He is a smooth lefty like his dad, whose form replicates that of his father. According to Schmitzer, Petraglia has averaged as much as 250 in league play. John is the ideal anchorman because he has ice water running through his veins. When a strike is needed to win the game John always comes through.

Middleman Steve Yeager is also a lefty who regularly averages 230 or higher. While he isn’t as well known as his teammates, he regularly outscores them. He also comes from a family of bowlers and has the highest average on the team.

As the league season comes to an end and the guy’s averages (Schmitzer 232, Yeager 233 and Petraglia 231) are down some, they are still putting up big numbers. All three have rolled perfect games and 800 series during the season and the night I watched them bowl Petraglia rolled a perfect 300 game. That’s it folks. Now you know. Now you know when it comes to trio teams, the best I’ve seen is the threesome of Schmitzer, Yeager and Petraglia.

Tour title, 196-180, to advance to the title match.

“I could tell it wasn’t going to be a strikefest but I like the challenge of thinking your way out of trouble and that’s the way it was the whole tournament,” Torgersen said. “Once you get in that mindset that’s how the tournament is going to be, you just adjust to it. Don’t get me wrong, I’ll join in on a strikefest party, but if it’s not, I’m not afraid of making the big changes you need to make on a challenging condition.”

Torgersen also had a two-season stint on the Go Bowling! PBA Tour 15 years ago when he had a career-high third-place finish in the 2005 Birmingham Open.

In the opening stepladder match, No. 5 seed 2018 PBA50 Rookie of the Year Rolando Sebelen of the Dominican Republic, defeated No. 4 seed three-time Team USA member Steven Smith of San Diego, 246-200, to advance to the second stepladder match against Duke. Sebelen, who finished fourth, improved on his 10th-place finish in his Senior U.S. Open debut in 2018. Smith, also bowling as a non-member, finished fifth improving on his eighth-place finish in 2018.

In the second match, Duke defeated Sebelen 245-193 to advance to the semifinal against Torgersen.

Earlier this season the 55-year-old Duke won the Go Bowling! Indianapolis and Go Bowling! Jonesboro Opens for the 39th and 40th PBA Tour titles of his career becoming the oldest player to win back-to-back tour titles.

The 2019 PBA50 Tour season will take a four-week break before starting up again with the PBA50 River City Extreme Open presented by Hammer July 9-12. 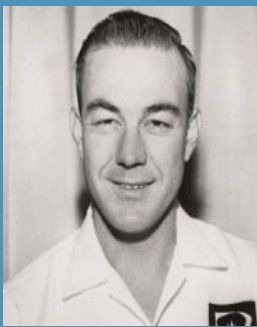

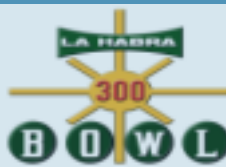

# IN A PERFECT WORLD

In a perfect world, every shot we deliver would produce a strike. While that would be boring, Glenn Allison lived in that world for a few short hours on July 1, 1982. Unfortunately, sanctioning for his 900 series was unfairly denied by a bureaucrat named Burt Kellerman. It continues to be withheld from him by other bureaucrats named Chad Murphy, Jason Overstreet, and a team of 19 USBC Board members.

In a perfect world, the leadership of our sport would guide it with wisdom, honesty, integrity and nobility of character. But we don't live in a perfect world; the USBC is proof of that. It is a man-made institution run by flawed human beings. That may sound harsh, but it's true.

Recently, a friend\* shared a story which spoke to the character of the folks behind OZ's curtain at the USBC. The story goes that some people were using "social media" to post mean-spirited messages about decisions made by the local USBC officials. Not knowing what to do about it, they called the USBC's regional representative\* for advice. Without even asking if there was any merit to the postings, his reply was, "Do not respond to any email or negative publicity on Facebook, or any media sites. There is no winning in those situations." In other words, his advice was to just ignore it until it goes away.

In today's world, that may be sound advice, or it may be cowardly. Whichever the case, it is how the USBC operates, particularly when it comes to dealing with the issue of Glenn Allison. That's a shame because failure to sanction his 900 is the biggest stain on the history of our sport. Ignoring stains doesn't make them go away.

Over the past two months, The Perfect Game has focused on the topic of Glenn Allison not being officially recognized as the original Mr. 900. These articles have pointed out the unfairness of his treatment by:

- restating historical writings and developing a compelling and logical case for the USBC to overturn the ruling of its predecessor, the ABC.
- challenging the honesty and integrity of the statement issued by the USBC\*\* on November 22, 2014 which, by default, denied Mr. Allison any hope of ever having his achievement sanctioned.
- providing a mechanism for the retroactive sanctioning of the series.
- respectfully requesting an explanation for the USBC's lack of action on this matter.
- providing unquestionable proof that at least one peer-group of the USBC would support a post factum sanctioning of Glenn Allison's 900 series.

Prior to publication of any of these articles, most have been submitted, via USPS, to both the USBC Executive Director and Deputy Executive Director. It seems, because

The Perfect Game has been critical of the USBC, they have followed their own advice and have not responded.

Several of the articles, including this one, were sent via email to every member of the USBC Board of Directors. To date, there has not been a single response from any of them either. Is that sound leadership, or cowardice? As always, you must decide that for yourself.

In a perfect world, the USBC would have the wisdom to understand the angst created by the ABC's abysmal decision back in 1982 and done something to rectify the matter. As stated, many times before, they could retroactively place Allison's name atop, "The List of 900 Series Bowlers," or release the evidence they hold which proves, unquestionably, that he doesn't belong there. Instead, they choose to hide behind the lies and platitudes of the statement released by the USBC in 2014.

In a perfect world there would be no need to fight for what's right; leadership would see to it without being prompted. In a perfect world, the ABC would have seen to it that Allison's series was sanctioned soon after it was delivered. In a perfect world, there would be no need for the USBC to clean up the mess created by the ABC.

Regarding Allison's legendary 900 series, there is evidence that the ABC did not act in good faith. There is ample evidence that Glenn Allison deserves official recognition. There is no irrefutable evidence that his 900 series doesn't deserve to be sanctioned. In other words, it isn't that the USBC can't sanction his 900 post facto, it's simply that they won't. That's as big a mystery as the ABC's failure to do so in the first place. Instead of providing a justification for maintaining the status quo, the USBC continues to follow their policy of, "Run-and-hide until it goes away."

We expect better from the folks in charge of the USBC. We expect them to guide our sport with wisdom, honesty, integrity and nobility of character. But, as stated earlier, we don't live in a perfect world; the USBC is proof of that.

Although both players fought to find the best look on this week's 37-foot oil pattern during the title tilt, the match was separated by just three pins, with Andersson having the advantage, heading into the ninth frame.

Andersson, a 27-year-old right-hander, quickly gave the advantage back, leaving a 7-10 split she was unable to convert.

With the open going into the 10th frame, Andersson finished on the left lane, where she had not delivered a strike in her first four attempts, and rolled three strikes to force Coté to strike on her first shot for a chance to win or record a spare and strike for a tie.

"The shot in the ninth wasn't that great, and I wasn't too happy about it," Andersson said. "But I knew to just go and take one pin and see what the scores were. I knew there still was a small chance I could come out as the winner."

Coté, working on a strike in the ninth, left a light-pocket 8 pin and converted the spare to start her 10th frame. Needing a strike to force a one-ball roll-off, Coté delivered a flush pocket hit only to find another 8 pin and second consecutive runner-up finish at the PWBA Fountain Valley Open.

"I literally started crying," said Andersson, who was the runner-up as the top seed at the 2016 United States Bowling Congress Queens. "I'm still a little bit shaky, but I'm really proud I was able to do what I've been practicing for all these years - throw those strikes when it matters."

Coté was the top seed at the 2018 event at Fountain Bowl but fell to Danielle McEwan of Stony Point, New York, in the title match, 215-182. She was proud to be able to throw one of her best shots of the day when she needed it.

"I can take away a lot from today," said Coté, the 2016 PWBA Lexington Open champion. "I fought myself physically a lot just today. There were some games where I wasn't bowling well, but I kept fighting to make the best shots I could to put myself in position to win."

"Recently, I found myself not making the best shots under pressure, so I think I proved to myself I can handle that pressure and make that shot. I put the ball where it needed to go, but the pins didn't fall my way."

Coté advanced to the title match after defeating Colombia's Clara Guerrero, 209-190. Guerrero held a slight advantage heading into the ninth frame but also was slowed down by a 7-10 split.

Coté, who had rolled strikes in her eighth and ninth frames, secured the win with a nine count on her first delivery in the 10th frame.

In Saturday's first match, Guerrero delivered five consecutive strikes starting in the second frame to outdistance hometown favorite Missy Parkin of nearby Laguna Hills, California, 238-189.

Parkin finished in fourth place at the Fountain Valley Open for the second consecutive season.

Competition this week at the PWBA Fountain Valley Open included two eight-game qualifying blocks on Friday to determine the 32 players for Saturday's Round of 32. An additional eight-game block Saturday morning narrowed the field to 12 players, who bowled six additional games to determine the stepladder finalists.

The 2019 PWBA Tour season will continue Sunday at the U.S. Women's Open, the second major championship of the season. The event will be held at Texas Station in Las Vegas.

The first round of qualifying at the 2019 U.S. Women's Open will begin Tuesday at 8 a.m.

BowlTV will provide live coverage of qualifying and match-play rounds, and the top five competitors at the end of the week will compete for the title live on CBS Sports Network. The finals will take place Sunday, June 23 at 2 p.m.

During the summer series, EJ Tackett and Anthony Simonsen will both have opportunities to defend two titles won in 2018. Tackett and partner Liz Johnson won the Storm PBA/PWBA Striking Against Breast Cancer Mixed Doubles event in Houston, and Tackett also won the PBA Bear Open in Tulsa, Oklahoma. Simonsen will defend titles in Middletown, where he won the Gene Carter’s Pro Shop Classic, and in the PBA Wolf Open, a part of the 2019 PBA Summer Swing that will move from Tulsa to Aurora in August. The 2019 Go Bowling! PBA Summer Tour will have its own points list, with enticing and historic bonus incentives involving three inaugural competitions serving as top story lines throughout the Tour:

- The inaugural USBC Cup will reward the top five players in PBA Summer Tour points with bonus cash prizes, including \$20,000 to the points leader;
- The inaugural FloBowling PBA ATX Invite will award berths into a special event for the top eight PBA Summer Tour points leaders at Dart Bowl in the hometown of FloSports, Austin, Texas, on Sept. 21. First prize in the FloBowling Invite will be \$25,000 and all participants in the event will cash;
- The inaugural PBA China Tiger Cup will award the top eight PBA Summer Tour points leaders with expenses-paid trips to Shanghai, Nov. 19-21, for a 16-player singles event including eight Chinese bowlers, and a separate USA vs. China team match. All players will cash in the PBA Tiger Cup singles event which offers a \$20,000 first prize, and in the team event the winning five-player team will divide \$15,000.

The PBA Summer Tour events will be open to non-PBA members as well as members, but non-members will not be eligible for any of the special events or bonus prizes.

Points earned during the PBA Summer Tour will also count toward 2020 DHC PBA Japan Invitational and 2020 PBA Tour Finals eligibility, as well as figuring into consideration for the end-of-season Player and Rookie of the Year awards.

For PBA Tour rookies, the Summer Tour also means a resumption of the 2019 Bowl4life PBA Rookie Watch points competition, which will strongly influence Rookie of the Year voting at year’s end. USBC Masters runner-up Mykel Holliman of Collierville, Tenn., is the competition points leader among rookies followed by Kenneth Ryan of Farmingdale, N.J., and Patrick Hanrahan of Wichita, Kan. The 2019 PBA Rookie of the Year will receive a \$2,500 bonus from Chuck Gardner’s Bowl4Life Foundation and the foundation will donate an additional \$2,500 to a youth bowler scholarship in the ROY’s name.

All Summer Tour tournaments except the Aurora Open and the end-of-season FloBowling PBA ATX Invite will be Tier 3 events under the PBA’s Tier 1-2-3 points system. The Aurora Open will be a Tier 2 event. The PBA ATX Invite will be a non-points, non-title special event.
