

## Valerie Bercier Wins 2019 PWBA Rookie of the Year Award

ARLINGTON, Texas Valerie Bercier of Spring Lake, Michigan, planned to bowl just the first four events of the 2019 Professional Women's Bowling Association Tour season, but a strong start encouraged her to continue and she now has won the PWBA Rookie of the Year award.
The 28 -year-old righthander paced all rookies
in points during the 2019 PWBA Tour season, which determines the PWBA Rookie of the Year. Her 21st-place finish at the QubicaAMF PWBA Players Championship in Raleigh, North Carolina, helped her secure the honor.

RALEIGH, N.C. - Singapore's Cherie Tan capped a dominating performance at the 2019 QubicaAMF Professional Women's Bowling Association Players Championship by winning her first career major championship Sunday at Buffaloe Lanes North.
The 31 -year-old lefthander was the player to beat throughout the week at the third major of the 2019 PWBA Tour season and delivered nine strikes in the title match to post a 245 204 victory over Shannon O'Keefe of Shiloh, Illinois. Tan collected $\$ 20,000$ for the win.

The championship round of the 2019 PWBA Players Championship was broadcast live on CBS Sports Network.


## Denmark's Carsten Hansen Wins PBAWBT Storm Lucky Larsen Masters Title Seventh-year PBA member nearly perfect in earning his first PBA Tour title

HELSINGBORG, Swe- man stepladder finals and den - Denmark's Carsten Hansen, a 26-year-old seventh-year Professional Bowlers Association member, was nearly perfect Sunday in defeating American two-handed player Chris Via of Springfield, Ohio, 289-247, to win the PBA International-World Bowling Tour Storm Lucky Larsen Masters at Olympia Bowling for his first PBA Tour title.
Hansen, a PBA member since 2012 and a veteran of several PBA World Series of Bowling since then, dominated the Lucky Larsen Masters. He was the qualifying leader, earned the top berth in the four-
then threw 10 strikes to start the championship match before missing his chance for a 300 game when he left the 3 pin on his 11 th shot. Hansen won a title in a PBA Regional doubles event in Las Vegas in 2013 but had never finished higher than ninth place in a PBA Tour event (2014 PBA Cheetah Championship).

Via, who also was bowl ing for his first PBA Tour title, recorded his best career finish after eliminating fellow American players Jake Peters of Henderson, Nevada, in the first stepladder match, 245-238, and Michael Tang of San Fran cisco, 247-200, in the semi-
final match.
The Helsingborg tournament - named in honor of Swedish PBA star Martin Larsen - involved multiple six-game qualifying squads to arrive at 52 finalists. Qualifiers $17-40$ plus 12 other special qualifiers bowled the four-game Step One, with the top 16 advancing to Step Two along with qualifiers 1-18. The 34 players in Step Two bowled a six-game block, with the top 18 advancing to Step Three for another six-game round. The top four based on 12-game totals from Steps 2 and 3 determined the stepladder finalists.

## The Umpire Strikes Back

I was once pressed into service to officiate a "Little League" baseball game. Without so much as a facemask for protection, I dutifully stepped in behind the catcher as the first pitch was thrown. In the third inning, one pitch got away from the youngster on the mound and a white orb headed straight toward the batter's helmet. When he ducked forward to avoid the missile, the bat remained on his shoulder and the ball hit it. "Strike!" I called.

Even though that was the right call, every spectator can't be expected to know all the rules. Suddenly, one little old lady decided to publicly display her ignorance of said rules. In language nobody should use in public, this 60 -year-old battle-axe decided to let me have it. She unloaded both barrels of her 12-gauge vocal cords in my direction. I held my ground. It was the right thing to do.

Today I face a similar circumstance. Unexpectedly pressed into service to write articles for this grand periodical, I find my senses assaulted by the very body I have long trusted to guide this sport. I have revered both the ABC and USBC for over five decades, but that has changed. Fair play does not seem to be part of either organization's playbook. Every time I think about their treatment of Glenn Allison, I want to scream, "FOUL BALL!"

As you may know, on July 1, 1982, Glenn Allison became the first bowler to deliver a 900 series in sanctioned league competition. The location of his feat was La Habra 300 Bowl in La Habra, California. Local inspectors approved it* but the ABC sent Burt Kellerman from an office in Wisconsin to overrule them. The USBC stubbornly supports that monumental blunder to this day.
Over the past few months, this column has reported facts which prove Allison's 900 was legitimate. We showed that the ABC admitted to wrongly denying the sanctioning of a record set by Ray Orf prior to doing likewise to Glenn Allison. We have proven that Allison was unfairly denied his day in court. We have also proven that former USBC president Andrew Cain, lied about this affair in the USBC statement of 2014, titled, "USBC CONCLUDES RE-EVALUATION OF GLENN ALLISON 900 SERIES." That document slammed the door on Mr. Allison's chances of ever being officially recognized as "Mr. 900."

Prior to publication in the Bowling News, all this material went to USBC Headquarters, addressed to Exec. Dir. Chad Murphy, and or Jason Overstreet (Deputy Exec. Dir.), and every member of the USBC Board of Directors, including its president, Karl Kielich. Not one of them issued a response of any kind. Why not?

It's rumored that Mr. Murphy's salary is over $\$ 350,000 / \mathrm{yr}$. It is also alleged he has no college degree of any kind. One would think that a paycheck that size would obligate him to respond to the concern's bowlers have regarding this matter. Lack of a response from Murphy shows a callous disregard for those who care about Glenn Allison, this controversy, and the hallowed history of our sport. This issue creates questions about his legitimacy to remain in office. If he doesn't want to earn his pay, he should be removed by the Board. So far, they show no inclination to do so.

That having been said, a new season is upon us and, as written in a previous column (CBN June 13, 2019 issue), I am personally protesting this lack of response by boycotting the USBC. I refuse to support an organization that shuns a legend like Glenn Allison, ignores its memberships calls for his rightful installment atop the list of 900 Series Bowlers, and blatantly lies to the world about their reasons for not doing so.

What next? The league in which I compete has 16 teams. Each team has 4 bowlers and I spoke with many of them. By the end of our first competition, only 8 had decided to renew their USBC memberships (they still want to bowl in tournaments).

It's a start. I believe Glenn Allison deserves better treatment than he has received from either the ABC or the USBC. I also believe the dues-paying members of the USBC deserve to know why Andrew Cain lied, and why the USBC continues to hide behind those lies regarding Glenn Allison. If you agree, I pray some of you will join me and spread the word using social media.

If any bowler ever deserved to have an official decision overturned, Glenn Allison is that bowler. GOOD BOWLING!
*Four local inspectors checked the lanes almost immediately after Allison delivered his 900. Their names were Bob Ramirez, Edward "Bud" Pinchot, Terry Johnson and Bob Strange. Within minutes of completing his inspection process, Bob Ramirez told Glenn Allison, "Everything appears to be in order." On September 28, 2015, I spoke to Bud Pinchot about the measurements taken by the inspectors that night. He told me, "All four of us were within a board or two of each other." He followed that by stating,
"I HAVE ALWAYS FELT THAT GLENN ALLISON DESERVED TO BE RECOGNIZED FOR HIS ACHIEVEMENT."

## Defeats Steve Kloempken in Doulle-Elimination Thriller...

## Melininer Winins Sibuhamaal New Mexicico Opena ateminiss s More

RIO RANCHO, New Mexico - How do you spell relief? For 57 year old Duane Mellinger of Aurora, Colo rado, it's "Tenpins \& More," thank you.

Mellinger, a recent inductee into the Colorado State Bowling Hall of Fame, became the oldest winner of the New Mexico Open Tournament at Tenpins \& More in Rio Rancho, when he defeated Steve Kloempken of Pleasant View, Utah, in a double-elimination thriller
For his efforts, Mellinger received the first prize of $\$ 12,620$, and a free entry into next years tournament. Kloempken collected $\$ 6,570$ for his second place finish, followed by Matt Smith of New Mexico \$3,125; Rich Miller of Arizona \$2,300; and Tony Sambueno of Nevada \$1,960

After Mellinger defeated Kloempken in the regular phase of the 2-game final matches, Kloempken stepped up to defeat Mellinger by a score of 443-429, setting the stage for the final roll-off match and the title.
Mellinger took a commanding 244-203 lead after the first game, and held on to win with a 218 game, while Kloempken tallied a valiant 231 in the second game, giv ing Mellinger a 462-434 two game victory total.
Mr. Mellinger commented during the trophy presentation, "Wow! What a thrill! I never thought at my age I'd ever win a big tournament like this." The event garnered entries from North Carolina to Oregon (13 different states), and Canada. There were a total of 196 entries and a total prize fund of $\$ 65,075$. incredible," Bercier said. "Knowing my name will be announced next year, and in five years, for being the 2019 PWBA Rookie of the Year is an amazing feeling."

Bercier started her 2019 campaign with seventh-place finishes at the Nationwide PWBA Greater Cleveland Open and PWBA Lincoln Open, and she posted her best showing of the season at the PWBA Sonoma County Open, advancing to the stepladder finals and recording a fourthplace finish.

Her 2019 campaign did come to a close at the PWBA Players Championship, as she fell short of advancing to the season-ending PWBA Tour Championship.
"My expectations were to just bowl those events and see what happens," said Bercier, who made the televised finals at the 2017 U.S. Women's Open as a non-member, finishing in fourth place. "As soon as I decided to commit to the rest of the season, I set my sights on rookie of the year. I felt it was a pretty good season, but I'm sad I didn't give myself enough of a chance to make the top 16 because I struggled at the majors. I'm looking forward, though, and know the things I have to work on for next season."

Bercier made the decision to join the tour season after establishing her business, Berberry Health \& Wellness, in 2017. Bercier, a registered dietitian and certified health coach, managed the challenging lane conditions and responsibilities of work from week to week throughout the season, and she hopes she can inspire others through her efforts in both.
"I started my business in April of 2017, and we moved to Michigan in November that year," Bercier said. "I felt last year wasn't the right time to come out on tour, because I wanted to get that off the ground and create a solid foundation. It was a lot to manage both, but I love it. I want to help people get healthy, so if I'm able to come out here and bowl and create inspiration for others to take their health seriously, that's my mission."

Bercier has represented Canada in international competition since 2013 and was part of the junior team from 2008-2010. She also was a collegiate standout for the University of Nebraska, helping the Cornhuskers win the 2009 National Collegiate Athletic Association (NCAA) Women's Bowling Championship

Since the relaunch of the PWBA Tour in 2015, the honor of PWBA Rookie of the Year has been awarded to Stefanie Johnson of McKinney, Texas (2015); Singapore's New Hui Fen (2016); Poland's Daria Pajak (2017); and Jordan Richard of Tecumseh, Michigan (2018).

13. Bowlers must check in at least 30 minutes prior to scheduled squad time and must show proof of current membership by showing their 2019-2020 USBC membership card (or receipt) - or their USBC bowl.com printout that shows that the 2019-2020 membership card has been purchased.
14. Bowlers arriving late shall begin play and the score shall count beginning with the frame then being bowled. Missed frames shall be credited with a zero. Frames may not be made up.
15. Designated prize funds will be paid accordingly to each division within 30 days upon completion of the tournament, except when USBC headquarters has authorized delay in payment, pending settlement of any claim or protest which affects position standings.
16. This tournament is certified by USBC. The Tournament Manager shall be the authority to interpret USBC and tournament rules, policies and procedures in deciding disputes.
17. An appeal or protest of a decision involving eligibility or playing rules must be filed in writing with the Tournament Manager and the USBC before tournament prizes are paid. The decision of USBC is final and binding on all involved parties. Any violation of tournament rules is cause for disqualification, loss of entry fee, forfeit of all prize monies and possible suspension from USBC membership.

## HOLIIMAN CONTINUES TO PACE GO BOWLINEI PBA TOUR ROOKIES II POINTS

Former Junior Team USA member and three-time Teen Masters titlist Greg Young Jr. of Viera, Fla., was the top rookie performer in the FloBowling PBA Summer Tour, finishing third in the Harry O'Neale Chesapeake Open and fourth in the PBA Wolf Open as part of the FloBowling PBA Summer Swing presented by the Brands of Ebonite International in Aurora, Ill., but a slow start earlier in the year prevented him from gaining much ground on Mykel Holliman of Collierville, Tenn., in the 2019 Go Bowling! PBA Tour's rookie competition points race.

Holliman, the runner-up in the Tier 3 USBC Masters earlier in 2019 , ranks 36 th overall on the 2019 PBA points list with 8,390 points, but he's still comfortably ahead of five other players on the 2019 Bowl4life PBA Rookie Watch list. Kenneth Ryan of Farmingdale, N.J., is 57th $(4,760)$ on the points list followed by Wichita's Patrick Hanrahan (59th, 4,410); Greg Young (up from 78th to 65th, 3,940); Jake Rollins of Glen Rock, N.J. (75th, 3,148) and Mike Coffey of Melbourne, Fla. (80th, 2,990). Staus in competition points is one of several factors voters will consider in selection of the 2019 Harry Golden PBA Rookie of the Year at the end of the season.

The 2019 Harry Golden PBA Rookie of the Year will receive a $\$ 2,500$ bonus from Chuck Gardner's Bowl4Life Foundation and the foundation will donate an additional $\$ 2,500$ to a youth bowler scholarship in the ROY's name.

With his victory Thursday in the PBA Bear Open, the second event in the FloBowling PBA Summer Swing, Anthony Simonsen of Little Elm, Texas, became the youngest player in PBA history to qualify for eventual placement on the PBA Hall of Fame ballot. The thing is, he has a considrable wait ahead of him.

There are two key qualifiers to become PBA HOF-eligible. First is "title eligibility," which calls for winning a minimum of 10 "standard" PBA Tour titles or five "stan dard" titles plus two majors. The Bear Open was Simon sen's fifth standard title, won at age 22 years, 235 days. He also has won two majors: the 2016 USBC Masters and the PBA Players Championship earlier this year.

The second qualifier to get on the PBA HOF ballot is 20 years of PBA membership. Assuming he will remain a member, Simonsen will reach his 20-year requirement in 2033.

In that unusual record category, Simonsen displaced EJ Tackett of Bluffton, Ind., his victim in Thursday's Bear Open title match. Tackett became HOF "title eligible" when he won the 2017 PBA Tournament of Champions in Shawnee, Okla., at the age of 24 years, 191 days. Tackett, who now owns a total of 13 PBA Tour titles, also is on the wait list for participation eligibility. He'll be on the HOF ballot a year ahead of Simonsen, in 2032.

five of her next seven shots. O'Keefe's run came to an end after she left a 9 pin to start her final frame, giving Tan the opportunity to clinch her second PWBA Tour title with five pins on her first delivery of the 10th frame. Tan rolled a strike to seal the win.

Tan had switched between reactive resin and urethane throughout the week at Buffaloe Lanes North, and she elected to go with reactive resin in the title match.
"The lanes were picking up really early, especially the left one," said Tan, who won her first title at the 2016 PWBA Storm Sacramento Open. "So, I decided to bring up the surface on my resin ball and play in that area of the lane.'
Sunday's victory also helped Tan earn an invitation to the season-ending PWBA Tour Championship, which will take place in Richmond, Virginia, from Sept. 15-18,

Tan needed to win to earn the final spot at the Tour Championship. If she would have lost the title match, the final spot would have gone to Indonesia's Tannya Roumimper based on her spot on the points list. "I was thinking about it, but I didn't focus too much on it," said Tan, who was the runner-up earlier this season at the Nationwide PWBA Greater Cleveland Open. "I can't control the outcome, but it's a bonus for me. It's something I've only done once, so I'm really, really happy to be going back." O'Keefe won three games on Sunday to earn her spot in the title match, averaging more than 236 to get there. She was in search of her fifth title of the 2019 season and third career major

She fought the left lane during her semifinal win against Shannon Pluhowsky of Dayton, Ohio, and against Tan, and noted the missed spares to start the championship match were inexcusable. "I was playing the left lane, at minimum, three or four more than the right lane the whole day," said O'Keefe, who made her sixth championship-round appearance of the season. "I only made a three and three on the right lane, but it was more like a six and five on the left lane before it started to hook too early and I made the ball change."
O'Keefe's bounce back at the Players Championship after missing the cut at the 2018 event was a credit to her resilience, though, as she also locked up the PWBA Player of the Year award for the second consecutive season.
"I don't let the past negatively affect me," O'Keefe said. "I learn what I can from it and continue to move forward. I think that's what has made me mentally tough over the last few years. I don't let bad things hold me back. I learn and move on."
She defeated Pluhowsky in the semifinal, 231-191. Pluhowsky was looking for her second career PWBA Tour title and first win since the relaunch of the tour in 2015.

O'Keefe moved onto the semifinal by besting United States Bowling Congress Hall of Famer Liz Johnson of Palatine, Illinois, 257-213. Johnson was in search of her third win at the Players Championship after claiming the 2001 and 2017 titles.
O'Keefe rolled strikes on eight of her first nine deliveries to win Sunday's opening match against Ukraine's Dasha Kovalova, 222-195. Kovalova was looking for her third title of 2019 and second major after winning the USBC Queens. The 16 finalists for the Tour Championship also are set with the conclusion of the Players Championship.
Joining Tan, O'Keefe, Pluhowsky, Johnson and Kovalova in Richmond will be Danielle McEwan of Stony Point, New York; Jordan Richard of Tecumseh, Michigan; Missy Parkin of Laguna Hills, California; Clara Guerrero of Colombia; Liz Kuhlkin of Schenectady, New York; defending champion Maria José Rodriguez of Colombia; Bryanna Coté of Red Rock, Arizona; Stefanie Johnson of McKinney, Texas; Josie Barnes of Nashville, Tennessee; Shayna Ng of Singapore; and Sandra Andersson of Sweden.

All competitors at the 2019 PWBA Players Championship rolled 18 games of qualifying over two days to determine the 18 players advancing to round-robin match play.

Advancers bowled an additional 18 games in match play, including a position round, and 36 -game totals, including bonus pins, determined the five players moving onto the stepladder finals. BowlTV.com provided coverage leading up to the stepladder finals.

## Sean Rash Tons USBC Cup, FloBowling PBA Summer Tour Points Races

## Jason Sterner advances from 34th place to earn herths in FloBowling ATX Invite, trip to China

AURORA, Ill. - Jason Sterner's victory in the PBA Illinois Open, the concluding event in the FloBowling PBA Summer Swing presented by the Brands of Ebonite International, at Parkside Lanes Saturday was not only the most memorable of his 13-year PBA Tour career, but resulted in rewards far beyond his third career title and a $\$ 20,000$ payday.

The 35-year-old right-hander, newly-relocated to Rochester, New York, knocked off four future PBA Hall of Fame candidates - Anthony Simonsen, Little Elm, Texas; Sean Rash, Montgomery, Illinois; Jason Belmonte, Australia, and EJ Tackett, Bluffton, Indiana - to also earn 5,000 competition points that allowed him to share in three incentive programs tied to the FloBowling Summer Tour

For starters, he advanced from 34th place to fourth in the USBC Cup point standings to earn a $\$ 3,000$ bonus. By defeating Tackett for the Illinois Open title, Sterner denied Tackett the points he needed to overtake Rash for first place in the USBC Cup points competition. Rash won the USBC Cup, earning a $\$ 20,000$ bonus. Tackett finished second for $\$ 10,000$, Simonsen was third for $\$ 5,000$ and AJ Johnson of Oswego, Illinois, took home the $\$ 2,000$ bonus for fifth place.

By qualifying fourth in Summer Tour points, Sterner also earned a berth in the FloBowling ATX Invite that will take place on September 21 at Dart Bowl in Austin, Texas, and pay $\$ 25,000$ to the winner along with guaranteed money to all eight qualifiers. Sterner also qualified for an expenses-paid trip to China for the first PBA China Tiger Cup that will take place in suburban Shanghai November 19-21 where another \$20,000 tops the guaranteed money all eight will earn.

There were no major changes among the 2019 Go Bowling! PBA Tour's top eight money-winners who will participate in the second PBA Clash at the Kegel Training Center in Lake Wales, Florida, on October 21. The Clash will air on FOX on Nov. 3. With only money won in the ATX Invite remaining to influence the earnings list, Australia's Jason Belmonte is No. 1 and can't be caught.

Belmonte leads the PBA Tour with $\$ 275,290$ in official earnings. He is followed by Jakob Butturff, Tempe, Ariz., \$185,780; Kris Prather, Plainfield, Ill., \$173,990; EJ Tackett, Bluffton, Ind., \$166,695; Anthony Simonsen, Little Elm, Texas, \$155,690; Bill O'Neill, Langhorne, Pa., \$152,148, and Sean Rash, Montgomery, Ill., \$119,170, in seventh place. Norm Duke, Clermont, Fla., is eighth with $\$ 97,415$, and could be knocked out of the top eight if Kyle Sherman of O’Fallon, Mo. (in ninth place with $\$ 78,968$ ) wins the $\$ 20,000$ op prize in Austin

- PBA Hall of Famer Tom Baker of King, N.C.; Ron Profitt of Brookville, Ohio; Sam Ventura of Syracuse, N.Y., and Jerry Horn of Lexington, S.C., won titles in the PBA South Region's annual extended Labor Day tournament series for PBA50 and PBA60 competitors that ended Monday with the PBA50 Mooresville South Open presented by Columbia 300 at Victory Lanes in Mooresville, N.C. Baker kicked off the series by defeating fellow Hall of Famer Walter Ray Williams Jr. of Oxford, Fla., 239-219, in the final of the PBA50 Sky Lanes South Open in Asheville, N.C., on Aug. 25.

Three days later in Kingsport, Tenn., Profitt came out striking with a perfect game to defeat Greg McMahan of Dandridge, Tenn., 300-279, to win the third annual PBA60 Kingsport South Open at Warpath Lanes.

Ventura was next, winning the PBA60 Wilson \& Sons Termite and Pest Control Southern Open at Victory Lanes in Mooresville, N.C., where he defeated Jeff Bellinger of Columbia, S.C., 201-195, for the title.

In the series finale, Horn put together three strikes in the 10th frame to claim the victory over Craig Auerbach of Sunrise, Fla., 222-215, for the win in the PBA50 Mooresville South Open in Mooresville.

Along with his 36th regional title, Baker earned $\$ 1,800$. Profitt earned $\$ 1,800$ and his third PBA Regional win in the PBA60 Kingsport event. Ventura picked up his 10th regional title along with $\$ 2,000$. Horn also took home $\$ 2,000$ and his first PBA50 Regional title for the Mooresville win.
