TOURNAMENT FORMAT ANNOUNCED FOR 2024 BOWLTV PBA REGIONAL PLAYERS INVITATIONAL

Returning to the renowned National Bowling Stadium in Reno, Nev., the 2024 BowlTV PBA Regional Players Invitational will be held Dec. 12-15, 2024.

The top PBA and PBA50 Regional Tour players in the nation will be competing for the trophies named in honor of Chris Warren, who owns a PBA-record 47 PBA Regional Tour titles and 58 overall regional titles.

Players can qualify for the RPI via the season-long Regional Tour points list, which includes PBA Regional Tour events from Nov. 13, 2023 through Nov. 11, 2024, or through each region's RPI Qualifier.

The top 43 players in points from the 2024 PBA Tour, including two-time defending RPI champion Patrick Dombrowski, will be ineligible for the RPI.

The top 10 players from the 2024 PBA50 Tour points list will also be ineligible for the PBA50 division.

A top-10 2024 PBA50 Tour player, who finished

outside the top 43 on the 2024 PBA Tour, would be eligible in the PBA division.

More information on eligibility and qualifying for the RPI is outlined [here](#).

In Reno, PBA division players will compete for a \$15,000 first-place prize. The top 33 players will cash for a minimum of \$1,000.

All players will bowl 18 games of qualifying with the top 24 players advancing to bracket match play. The top eight qualifiers will earn a one-round bye.

Match play will consist of best-of-five-games Rounds of 24, 16 and 8, followed by a best-of-three-games semifinal and single-game championship match.

In the PBA50 division, the top 12 players will advance to match play after 18 games of qualifying. The top four qualifiers will earn a one-round bye. Two best-of-five-games rounds will be followed by a best-of-three-games semifinal and single-game championship match.

The PBA50 division offers a \$10,000 top prize and a \$1,000 minimum cash for 16th place. Bo Goergen is the defending champion.

All rounds of the RPI will be livestreamed on BowTV. The championship matches for each division will be staggered to allow for optimal coverage of each match.

Kings Bowl - A Center Fit For A King

While looking through all of the approved for publication photos that were provided to me by Chris Nichols and Elliot Kane from the soon to be published Bowlarama, I came across two photos from Kings Bowl in Millbrae, California, on the El Camino Real near the San Francisco International Airport.

Although I had bowled there during my youth, representing L & L Castle Lanes in the Bay Area Masters Traveling League, I never made much of a showing there. The top bowler at Kings Bowl and neighboring Millbrae Bowl was Pat Stewart, a promising lefty who later gave the PBA Tour a try, like many of us who were a part of the Bay Area Masters.

My fondest memories of Kings Bowl came in 1977, when the USBC state tournament was to be held at Kings and Millbrae Bowl. Due to the fact that I had been traveling the western swing of the PBA circuit the previous couple of years, I decided to try and field a team with some of my new found friends. Here's what I wrote about my memories of that experience a few years ago in this column:

"Larry Laub (my chauffeur) and Ron Lisher (my roommate on tour) were the first on my list, and they both said yes. Next up came Rich Carrubba from Hayward, and Tim Harahan from Marina Del Rey. Carrubba was an instant yes, but I had to coax Tim into joining by naming the team after his (and Laub's) new bowling center, Hawthorne Bowl, located about 30 minutes south from his home on the 405."

One thing that I failed to mention in the previous article was that Laub had recently moved to Santa Rosa, and was living with his best friend, Ron Lisher, and his parents. Larry loved Santa Rosa and the great outdoors. One of his favorite pastimes was to pile everyone into his motorhome and camp out along the Russian River.

I was invited to go on one of Laub's white water rapid adventures, with Larry, Ron, Palmer Fallgren, Jerry Buchholz and a few others. We were driven to a site north of the campsite and given giant inner tubes to float back down to our destination, where "the gals" were preparing a barbecue dinner of burgers and hot dogs with all the trimmings.

Jerry and I got separated from the rest of the group on a small but notorious section of whitewater rapids. There was a giant boulder ahead of us that could not be avoided. I was the first to hit and was completely submerged by the impact and force of the water.

That was enough for me, as both Jerry and I climbed to shore and walked the rest of the way back to camp. When we got there, we discovered that we were not the only ones that encountered some difficult rapids. Larry had dislocated his shoulder and was out of bowling commission for a while.

Larry's shoulder was never quite the same. It reminded me of my back pains. He could just bend over to pick something up, and his shoulder would go out. With that as a backdrop, the rest of the King's Bowl story makes a little more sense, as you will see below:

"We were all set to bowl when Lisher received a call the night before from Larry Laub. He had dislocated his shoulder, which was not uncommon. He told Ron not to worry and that he found a replacement (another pro) that would be there the next day to compete in the team event.



The following day we literally tore up the lanes, with the exception of our last minute backup. Lisher led the team with 720, and I was fortunate to follow his lead with 685. I don't remember the actual scores for Carrubba and Harahan, but they were both in the 640-650 range.

Our substitute, who shall remain nameless, was not on the same wavelength as the rest of the team and checked in with a 495 series. In the last frame, he was working on a strike in the ninth frame and left the 7-10 split. In utter frustration, he just threw the second shot away. 'What are you doing,' asked Harahan. 'You just threw away 2 pins that we might need.' In the end, Tim's comment was psychic, as we did indeed lose the scratch title by one pin."

During all those visits to Kings Bowl in the youth travel league, and later in the adult North Bay Travel League, as well as the aforementioned state tournament, I never took the time to notice the absolute beauty of King's Bowl. There was a regal feel to the place, with ground level parking and the lanes situated on the second floor. The cocktail lounge, known as The Blue Peacock, was renowned in the area for food and drinks.

There was also a rather large billiard room and coffee shop, supervised nursery for the little ones, and a pro shop offering private bowling instruction. The entry from the street level and parking garage was reminiscent of AMF Pro 300 Lanes in Portland, OR, Post Bowling Academy in White Plains, NY, and many of the AMF centers that I encountered in Australia and Hong Kong. After climbing the steps, you were suddenly in the center of the concourse, surrounded by many exotic plants and unusual lights "fit for a king."

Via, the defending Strike Derby champion, will be the top seed for the bracket.

Quintero was selected by the host center, Bayside Bowl in Portland, Maine. The Mexico native moved to Portland following his 2022 PBA League debut and has become a staple in the city's bowling community.

Quintero will be the No. 8 seed and face Via in the opening round of the bracket. The remainder of the players were seeded by their strike totals during the PBA Elite League regular season.

Hanrahan paced the field with 50 strikes, followed by Belmonte (47), Anderson (47), Tackett (43), Troup (39) and Svensson (34).

Belmonte won the tiebreaker over Anderson — each struck 47 strikes on 71 attempts — as the Australian netted more fan votes.

Each player will have two minutes to throw as many strikes as possible and the player with the most strikes will advance. Ties will be broken by a one-ball roll-off. The winner of the non-title event will receive \$30,000.

The event will be taped during the PBA Elite League presented by Snickers Playoffs at Bayside Bowl in Portland, Maine. More information on the PBA Elite League is available [here](#).

DOWNEY – The Brunswick Invitational took to the lanes for the start of the new season with 16 full teams ready to take on the house shot in the “warm up” round. Teams were paired up by random draw and looking to strike a lot on the fresh house shot.
