Francois Lavoie Wins U.S. Open

MOORESVILLE, N.C. - For the second time in his short professional career, Canada's Francois Lavoie donned the coveted green jacket at the U.S. Open.

The 26-year-old righthander defeated 14-time Go Bowling! PBA Tour champion and top seed Sean Rash of Montgomery, Illinois, 221-172, on Wednesday night to become the 12th bowler in history to win the prestigious title multiple times.

His first time hoisting the U.S. Open trophy was in 2016 on the way to PBA Rookie of the Year honors.

The latest win gave Lavoie his fourth PBA Tour title and made the fourthyear professional the first foreign-born player to win the U.S. Open more than once. Finland's Mika Koivuniemi (2001) and Dom Barrett of England (2018) also have won the event.

Wednesday's star-studded stepladder at Victory Lanes was broadcast live on CBS Sports Network.

Along with the iconic outerwear, Lavoie also earned a \$30,000 top prize. The U.S. Open was the fifth, and final, major of the 2019 PBA Tour season. The win was Lavoie's first since 2017. "This is so surreal, and I don't even know where to begin," Lavoie said. "To win the first one was unbelievable and a dream come true. Winning the second one, wow. Espe-

cially with the way the season started, I never could've expected this. It's not something you think will happen again, and definitely not this year of all years. I feel so fortunate."

Lavoie started the final match with five consecutive strikes and cruised to the title. Rash opened with a strike but did not throw another until the ninth frame when his third ma-

jor title already was out of reach.

Rash was in a familiar position as the No. 1 seed, having won the 2007 United States Bowling Congress Masters and 2012 PBA Tournament of Champions from there.

"I'm great, honestly," Rash said after the loss. "I led the U.S. Open, which is a dream come true. I've always wanted to make this show. Frankie bowled unbelievable. He started with the front five on a pair that was extremely brutal. He's a two-time champion at this event for a reason. It was a great performance, and he out-bowled me. I'm happy with my preparation and thought process and every-

thing that was going on. I have no regrets from to-day, and I feel like this still was one of my best seasons

Despite the loss, Rash indeed is winding down one of his best seasons in a career that began in 2005. His 2019 campaign includes two titles and more than \$145,000 in earnings. He took home \$15,000 for Wednesday's runner-up fin-

In the night's four matches, there only were three strings of strikes longer than a double, and Lavoie had two of them on what he considered the most challenging of the week's four oil patterns.

LAKE WALES, Fla. (Nov. 3, 2019) – Jakob Butturff of Tempe, Arizona, outlasted seven other top money earners from the 2019 Go Bowling! PBA Tour season and defeated EJ Tackett of Bluffton, Indiana, in the championship match to win the \$50,000 winner-take-all prize in the second PBA Clash which aired Sunday on FOX Sports from the Kegel

Training Center. The 25-year-old lefthander, who has won three titles in 2019 including the USBC Masters for his first major, got off to an inauspicious start in the championship match, throwing a gutter in the first frame. He learned from his mistake, converted the spare, and threw strikes in nine of his next 11 shots to beat Tackett, the 2019 Barbasol PBA Tour Finals winner, 258-244, for the win.

"If I'm executing the way I should, throwing the ball out to the gutter is my best look and where I get the best results," said But-

turff. "Obviously you don't want to throw it (into the gutter) in a critical situation but if it's going to happen that's the place to do it because you have time to recover."

The eliminator format event showcased the season's top eight money earners from the 2019 season concluding with the FloBowling ATX Invite continued on page 4



PBA Star Tommy Jones Elected To PBA Hall of Fame

time title winner Tommy Jones of Simpsonville. South Carolina, and former ownership partners Mike Slade and Rob Glaser have been elected to the Professional Bowlers Association Hall of Fame, PBA Commissioner Tom Clark announced today.

Jones was unanimously elected for superior performance by an elite panel of veteran bowling writers and PBA Hall of Famers. Slade and Glaser were elected for

meritorious service by the PBA Hall of Fame Board.

Induction ceremonies of the 2020 Hall of Fame Class will take place on Saturday, Jan. 18, at the International Bowling Museum and Hall of Fame, and the Arlington Hilton, in Arlington, Texas, as part of the PBA Hall of Fame Classic tournament weekend.

Jones, one of five PBA players to win both PBA Rookie (2001-02) and Player of the Year (2005-06) honors, has earned more than \$1.7 million in his 20-year PBA career. The 41-year-old power player owns 17 standard PBA Tour titles plus two majors: the 2006 U.S. Open and 2007 PBA Tournament of Champions. He has finished in the top 10 in annual PBA Tour earnings nine times and has finished in the top five in 47 of the 326 PBA Tour tournaments he entered, cashing in a remarkable 80.3 percent of those

An 11-time member of Team USA, Jones also has been on winning teams in PBA League Elias Cup competition three times and was the recipient of the PBA League Mark Roth Most Valuable Player Award in 2017.

"It's one of those things I probably wouldn't have known was coming if I hadn't seen an article about being on the ballot," Jones said of his election to the Hall. "It's a huge honor to be among all of those players who are in the Hall. It's something you dream about all of your life. It'll probably hit me when I'm standing up in front of the crowd to accept."

Defining moments in Jones' career? "For me, it's a combination of things. The U.S. Open title was big and being selected No. 30 among the top 50 players in PBA history (in 2009) as the youngest one (age 30) also was pretty cool for me," Jones said. "The U.S. Open was defining because I bowled so bad the previous year. The Tournament of Champions at Mohegan Sun also was a great win because that's the one title every PBA member wants to win. It's really special to be on that list of winners."

Jones admits his career isn't over: his ultimate goal is to reach 25 PBA Tour titles and that goal is still alive.

"It's not unrealistic," Jones said. "My body is finally healthy again. My back was bad for a while, but now it seems to be good.

"We have a lot more events now, in a lot of different centers, which makes a difference," he continued. "At this point in my career, there isn't a whole lot I haven't seen. One of the reasons this game is so great is that you can never master it. But I figure, with my experience, I may be better prepared than some of the younger guys."

Slade and Glaser will join their original PBA ownership partner, Chris Peters, in the PBA Hall of Fame. All three were former Microsoft executives who combined resources to purchase the PBA in 2000, pulling the organization back from the brink of bankruptcy, and providing the organization with leadership from their board of directors positions and the financial support to remain viable until its recent sale to Bowlero Corp. Slade's creativity and contacts at ESPN and with leaders in sports media were key assets in advancing the PBA brand and opening doors with new partners including FOX Sports.

Slade began his career at Microsoft in 1983 and spent seven years there in a variety of product marketing roles. In 1993 he was hired as CEO of Starwave, Paul Allen's trailblazing venture into the Internet and multimedia where he launched ESPN.com, NBA.com, NFL.com, NASCAR. com, ABCNews.com and the Go.com network. He retired as Chairman and CEO of Starwave following its sale to the Walt Disney Corp. in 1998.

Slade then served as strategic advisor for Apple Com-



puter CEO Steve Jobs, and as a strategic consultant for ESPN, NBA.com, NFL.com, Starbucks, Real Networks, Disney, and various Paul Allen companies. In 2000, he cofounded the venture capital firm Second Avenue Partners and he became a co-owner and board member of the PBA.

"It's a real honor to be elected," Slade said. "I kind of got involved with the PBA by accident and I wound up being the owner. "When we left Microsoft, Chris Peters got into bowling instead of golf, and he was really excited about it," Slade reflected. "Then he found out the PBA was about to go out of business, so he approached Rob and me about buying the Tour. I had a sports background; I was once a sportswriter and the company I was affiliated with at the time was involved with a number of sports.

"I had a lot of experience at the intersection of sports and tech(nology), so I was excited to get involved. When we did the deal with ESPN way back when, that was me getting involved. "We hired good people and we ran the PBA like a real professional sport," Slade added. "We always felt (the PBA) was going to advance in the sports world, but ultimately it needed a bigger plan, so that's why the deal with Bowlero made sense."

Glaser, a New York City native, was the PBA's principle investor financially, largely funding the early 2000's efforts to boost prize funds, regulate TV exposure and further explore arena settings. After a 10-year career in a variety of positions with Microsoft, Glaser founded Real-Networks in 1994, a company that produces RealAudio, RealVideo, RealPlayer, and Helix, among other products and services. A Yale graduate with degrees in Computer Science and Economics, Glaser has been a major donor supporting a wide range of humanitarian causes throughout his career. "In 1999, my good friend Chris Peters approached me with the opportunity to get involved in what he called "saving the PBA," Glaser said. "I was a lifelong bowler and PBA bowling fan, so I happily said yes.

"It's a true honor (to be elected)," he added. "I have so much respect for the incredible athletes who make up the core of the PBA Hall of Fame. Other than Mike Slade, I am certainly the worst bowler ever elected to the PBA. But the last time I bowled I rolled a 217, so that's something."

In addition to the inductions in Arlington on Jan. 18, the PBA also will present the 2019 Chris Schenkel Player of the Year; Harry Golden Rookie of the Year; Steve Nagy Sportsmanship Award winner and PBA Tony Reyes Memorial Community Service Award winner. The winners of those annual awards will be announced later this year.

in September. In addition to Butturff and Tackett, other players earning berths in the non-title special event were Australian twohander Jason Belmonte, Sean Rash, Anthony Simonsen, Kris Prather, Bill O'Neill and 55-year-old PBA Hall of Famer Norm Duke. Competition began with all eight bowlers completing a 10th frame opening round with the low score eliminated. The seven remaining players then bowled subsequent rounds which consisted of a one-ball, low-man-out format. The two survivors advanced to the complete-game winner-take-all finale.

After the 10th frame round, Prather, the winner of the \$100,000 first prize in the inaugural PBA Playoffs in June, was eliminated with a nine-count for the frame after leaving the 2-8 and failing to convert the spare. Butturff faced early elimination in the 10th frame round after leaving 2-4-6-7-10 split on his first ball, but he converted the spare and struck on the final ball to advance to the second elimination round.

"It was a bad shot; I thought it was the end of the tournament for me," said Butturff, who was eliminated late in the one-ball elimination round of the inaugural Clash in 2018. "If I make the spare, it's probably going to be the most difficult spare I've made on TV so I told Kris (Prather) it would be awesome for the TV show if I can make it. You have nothing to lose at that point so the pressure's off – just take your best shot and hope for the best."

In the one-ball elimination that made up rounds 2-6, Tackett and Butturff were the last two players left standing with a strike and nine-count, respectively. They outscored 2019 PBA Players Championship winner Anthony Simonsen in the sixth round after he could only manage seven pins, leaving the 3-6-10.

Duke was eliminated in Round 2 with a seven-count after four roll-offs. O'Neill was eliminated in Round 3, which also required four roll-offs, with nine. Rash was eliminated in Round 4 with eight, and Belmonte was eliminated in Round 5 after two roll-off frames, with nine. "A format like this really tests your ability to think on the fly so you can give yourself the best opportunity to perform in the clutch," said Butturff, who has had issues missing easy spares at critical times in matches in the past. "In the early rounds your mindset is 'don't do worse than they did' but eventually that changes to putting pressure on your opponent when you bowl head-to-head in a title match.

You had eight guys who got here because of their ability to come through in clutch situations," Butturff added. "It can be nerve-racking but this is what I love to do so you just get into competitive mode and get the job done." The 2020 PBA Tour season begins with the PBA Hall of Fame Classic Jan. 14-19 at the International Training and Research Center on the International Bowling Campus in Arlington, Texas. The stepladder finals will air live on FS1 on Sunday, Jan. 19 at 10 a.m.

His keys to success on all the patterns were surface management and different hand positions.

"I wasn't ever really comfortable on this pattern for the 32 games we bowled on it, and going into match play, I was pretty nervous about holding onto a spot on the show for another 24 games," said Lavoie, who averaged less than 200 for his first eight games on the week's final oil pattern. "I had a hard time getting my hand to do what I wanted to get the right ball motion, but we stuck with it and stayed in it. Throwing the front five in the final game was huge, especially since our plan was just to try to hit the 1-3 every time. That pair was really hard."

On the way to his first U.S. Open title in Las Vegas, Lavoie also managed to string strikes in what is considered one of the sport's toughest environments. That year, he also was the second seed and advanced to the title match by becoming the first bowler in history to roll a perfect game on a U.S. Open television show.

Lavoie rolled into this year's championship match simply by filling frames, another key to success on the demanding conditions at the U.S. Open.

The Team Canada member posted a clean 214-164 win against two-time major champion Anthony Simonsen, 22, of Little Elm, Texas, who was looking to earn his eighth PBA Tour title and become the youngest player to win three majors.

Simonsen, who won the 2016 USBC Masters and 2019 PBA Players Championship, advanced to Wednesday's semifinal with a 187-148 against 11-time major champion and 2019 PBA Player of the Year front-runner Jason Belmonte of Australia.

After three solid shots to start the match, Belmonte failed to get more than six pins on four of his next five first balls. The 36-year-old two-hander tried everything to get back in the match, including a switch to a urethane ball in the seventh frame and moving from the left side of the lane to the right.

The move worked on the right lane, but the 22-time PBA Tour champion split twice on the left lane, including the 2-8-10 combination in his final frame. A missed 10 pin from Simonsen in the ninth frame gave Belmonte an opportunity to at least force Simonsen to mark, but the final split ended his chances for a fifth title in 2019.

A win Wednesday would've given Belmonte his first U.S. Open title, and he would've joined USBC and PBA Hall of Famer Mike Aulby as the only players to win the Super Slam.

Belmonte has four wins at the USBC Masters, three PBA Tournament of Champions titles, two victories at the PBA World Championship and two wins at the PBA Players Championship.

His 148 game was the lowest he has bowled on TV. His previous low came in a 214-156 loss to Wes Malott in the title match of the 2013 U.S. Open.

In Wednesday's opening match, neither Simonsen nor Bill O'Neill of Langhorne, Pennsylvania, looked immediately comfortable on the fresh 40-foot oil pattern, but two rolled 10 pins early in the game gave Simonsen a small advantage over O'Neill, who didn't deliver his first strike until the fifth frame.

A 2-8-10 split from O'Neill in the sixth frame widened the deficit, and Simonsen followed the first commercial break with four consecutive strikes to pull away for a 226-193 victory.

O'Neill, the 2010 U.S. Open winner, also was looking to become the 12th bowler in history to win the event multiple times. The 38-year-old right-hander owns 11 PBA Tour titles, including two this season.

The field this week started with 144 players, all of whom bowled 24 games of qualifying over three days (eight games each day). Each round featured a different oil pattern, and a fourth lane condition was introduced for the cashers' round, match play and championship round.

The U.S. Open is conducted jointly by USBC and the Bowling Proprietors' Association of America.



LA HABRA – October 3rd, 2019 Glenn Allison joined managers Annette and Ed on lanes 13 and 14 for a special presentation read by Stacey (Annette's daughter).

"Many people have bowled a 300 game, several have bowled an 800 series, but only one individual has bowled a 900 series here at La Habra 300 Bowl.

On July 1, 1982 Glenn Kichard Allison, down on lanes 13 and 14 bowled the first nine hundred series in sanctioned league play.

Unfortunately, American Bowling Congress, now known as USBC, has denied recognizing his series.

But tonight, of USBC recognizing his series, The United States Congress as of October 3rd, 2019, thirty-seven years later, is recognizing him as the first man in the history of bowling to deliver a nine hundred series in sanctioned league competition and is now officially recognized as the original Mr. 900.

We would like to thank Mr. Jose Luis Correa from the 46th Congressional District for recognizing this monumental accomplish-Submitted by La ment. Habra Staff.

The Man Behind The Campaign

A few years ago, a fellow named Steven Felege sent me a "bowling book" The Essentials of Bowling, to read and give him my opinion. How did a guy from Erie, Pennsylvania choose The Bowling News? Because there are only 4 papers left in the U.S.A!

I read his self help book and was annoyed by the use of "bowling alley." When I called him with minor complaints, we hit it off. He even had the publisher change alley to center before 10,000 books were printed and went on sale.

Steven is retired, a bowler, a fisherman, and a thinker. He asked if he could write an article or two. Six year later we have published his entire book and MANY articles.

Five years ago, Steven commented that he was running out of ideas. He asked if I knew Glenn Allison from California. I said sure. "We all know how his 900 series was never sanctioned and probably never would be." "I've known Glenn for 30 years, even have a t-shirt he signed."

Steven wanted to know more. He contacted the U.S.B.C. They said it (900) had been denyed by the A.B.C. and they couldn't do anything about it. In fact, they had NO RE-CORDS. Steven contacted a couple of past A.B.C. directors. They said that all ABC records were either destroyed or in a ware house.

Steven talked to Glenn. The papers that his lawyer had disappeared when he died. The trail was COLD, DEAD, DESTROYED. After a few weeks, Steven decided if he couldn't get the 900 approved, and be the official first, he would go in another direction.

He started a campaign that boggled my mind. He wrote to every USBC official pleading for a hearing. NO RESPONSE FROM ANYONE.

What next? He wrote to Donald Trump and every member of Congress! He wrote more articles for our paper and pleaded for everyone to write their congressman. All he wanted was for Glenn Allison to get the honor he deserved.

On October 3, 2019 at La Habra 300 Bowl Glenn was presented a "Certificate of Special Recognition" from the House of Representatives of the U.S. Congress declaring him the "Original Mr. 900". A bowling Congressman must have gotten the memo!

Steven Felege contends he is not a writer. I contend that he is a fighter, a friend, and a person who shook the bowling world and found the golden apple.

The Road Retraveled

THE PLOT THICKENS

When faced with an unusual case, judges rely on rulings from similar trials. Prior rulings are referred to as "case law." It's important to remember that judges are people and people make mistakes. Therefore, judges make mistakes.

When Glenn Allison tried to sue the American Bowling Congress for recognition of his 900 series, it seems case law for his suit was in the process of being established. It involved the Nebraska Supreme Court, case No. 83-885; Straub v. American Bowling Congress. Here is the background for that trial.

On Nov. 16, 1979, Bill Straub* shot a 300 game as part of an 836 series in sanctioned league competition. The lanes were quickly inspected and found to be non-compliant. The inspector was Roger Florom, the secretary-treasurer of the Lincoln Bowling Association. At the time, he also held the local high-series record of 813 and had stated to a friend that he would use his position in the LBA to prevent any bowler from surpassing his score.

Straub sued, alleging breach of contract, fraud and negligence on the part the ABC and its affiliates. Because he couldn't prove any of his allegations of wrongdoing by the ABC, he lost on all counts. While Florom's inspection was a conflict of interest, it wasn't illegal and was conducted properly. The point is that Straub was not prohibited from challenging the authority of the ABC. In fact, he was allowed to appeal all the way up to the Nebraska Supreme Court. The case law this trial created may have impacted the proceedings of Allison v. ABC.

The first relevant point made in the Nebraska Supreme Court file is this: "Members of the ABC agree, upon becoming members, to be bound by the ABC rules and to grant jurisdiction over all bowling disputes to the ABC."~

When Glenn Allison filed his suit in the U.S. District Court, Central District of CA., did the ABC's lawyers request the case be thrown out, citing this point? The records from that system are no longer available, but one newspaper report states, "After his original appeal was denied by the ABC, Allison filed a lawsuit, but the case never made it to court. The judge explained that Allison was a card-carrying member of the ABC and had to abide by its governing decisions."**

Was that a coincidence? If so, why did the USBC lie in its press release of 2014 by stating, "The ABC's decision was litigated before the United States District Court, Central District of California which upheld the ABC's determination in all respects."*** Lies are generally told to hide something. What may the USBC be hiding? Is it that "the fix" was in on Glenn Allison, just as it seems to have been for Ray Orf?

The CA District Court Judge's mistake was that he/she apparently did not review the Nebraska case more thoroughly. Had he/she done so, Allison would have gotten the trial he deserved due to other relevant points made in that case. The Nebraska Supreme Court file points out that court actions may be maintained for the purpose of determining:

- if the ABC and/or its affiliates "violated the contractual terms of membership" (breach of contract). Rules for dealing with honor scores were in place. Those rules are part of the membership contract and include inspection of lanes by a local inspector whenever a high score occurs. In Orf's case, the ABC tried (unsuccessfully) to prevent such an inspection, a clear breach of contract. In Allison's case, no such breach occurred, but the results obtained by the four local inspectors were discounted.

-if "there are inconsistencies between an association's rules and the actions taken." ~ As stated above, rules for dealing with honor scores were in place. Those rules included examination of lanes by a local inspector, <u>ASAP</u>. It was inconsistent with this rule for the ABC to rely on inspections from people flown in the next day. And yet, those inspections were the ones the ABC relied upon to prevent sanctioning scores which would have been approved by the local inspectors. Had the ABC followed their own standard procedures, both Orf's and Allison's series would have been sanctioned. This entitled Allison's case to be heard

- if "the government of the society is administered fairly and in conformity with its laws and other applicable laws." ~ Excessive scrutiny does not conform to the historical actions of the ABC. Were inspectors sent from ABC headquarters when the first 300 was delivered? How about when someone shot the first 800? Probably not! These two men were singled out and punished by the ABC simply because they surpassed Allie Brandt's record. There was a set of protocols for ordinary honor scores, another set for honor scores that eclipsed Allie Brandt's record. What's fair about that? This entitled Allison's case to be heard.

- "whether the member has been treated unfairly in the proceedings." ~ It seems obvious that neither Ray Orf nor Glenn Allison were treated fairly. The ABC took extraordinary measures which cost these men their immortality. In both cases, the ABC broke from their standard procedures by flying in Roger Tessman, who denied Orf's series; for Allison, they flew in Burt Kellerman. In Orf's case, the ABC admitted they mistreated him by paying him a monetary settlement. Being treated differently is the essence of unfairness. This entitled Allison's case to be heard.

- if "property or civil rights had been violated." ~ Glenn Allison's civil rights may have been violated if, as mentioned above, the ABC lawyers took actions which prematurely and abruptly ended his lawsuit. Trial in a court of law is the most fundamental of our civil rights. Perhaps this is the reason Andrew Cain lied in the USBC statement of 2014. Was it to hide that the ABC had violated Glenn Allison's civil rights by convincing a judge to throw out a lawsuit for which he was eligible? This would certainly explain why the USBC is now silent on this issue. This entitled Allison's case to be heard.

- if "the association's actions were prompted by fraud, malice, or collusion; and whether the association's rules contravene public policy or law." ~ There is no evidence in the records that suggest malice on the part of either the ABC or USBC. If the suspicions about the Allison controversy are true, both fraud and collusion would certainly be possibilities. Fraud would be the denial of one high-score record to preserve another. As for collusion, it would require nefarious teamwork to cover up a story about Ray Orf and Glenn Allison being denied immortality. It would also require collusion to hide an inconvenient truth about the ABC violating Glenn Allison's civil rights.

Collusion, in this case, may consist of networking to ensure no officer or Board member deviates from the USBC policy which states, "Do not respond to negative media of any kind." This may be the reason the USBC fails to address its membership about the lies contained in the press release of 2014*** This casts doubt upon the integrity of both the ABC and the USBC. While this circumstance entitled Allison's case to be heard in a court of law, at the present time it also calls the USBC's motivation into question.

"A member bowling in an ABC-sanctioned league becomes eligible for ABC recognition of certain high scores if that score was achieved under conditions which are in conformity with ABC rules." We know that the lanes were acceptable to the local inspectors when Glenn Allison delivered his 900 series. Bob Ramirez, the lead inspector, told Glenn Allison, "Everything seems to be in order." Edward "Bud" Pinchot, one of three additional inspectors called in by Ramirez, told me, "I have always felt that Glenn Allison deserved to be recognized for his achievement."

Unfortunately for Glenn, what we know and what we can prove are different. For Glenn Allison's 900 series, the statute of limitations has expired in the legal system. In the court of public opinion however, this case will never die. Glenn will someday be officially recognized for what he accomplished. It may not be by the folks who presently run our sport, but almost certainly by some of our leaders in the future.

MOVING ON!

A while ago, trying to have Glenn Allison recognized as a national treasure rather than just a bowling legend sounded like a good idea since the USBC is MIA concerning this affair. All they want is for his story to disappear, and that's just not right.

The White House seemed a logical place to start the process since Donald Trump loves recognizing Americans who have made exceptional contributions to this country. Glenn Allison certainly fits that bill. He alone proved that rolling a perfect series while bowling within sanctioned protocols was possible. Though scorned by the bowling authorities, he appealed, but never publicly complained. In fact, he became one of the greatest bowling ambassadors that ever lived. He is also a veteran of the Korean War.

I have called the White House for (How-To) directions for nominating someone to receive the Presidential Medal of Freedom. One time I was actually able to speak to someone and was told to

begin the process with my congressman. I thought he was just trying to pass the buck. After all, it's the *Presidential* Medal of Freedom we're seeking for Glenn; not the *Congressional* Medal of Honor. While I, along with many of our readers, continue to badger the White House about this issue, only a few replies have come forth.

<u>Eureka!!!</u> As I have said many times, there is a way to get Glenn Allison the recognition he deserves, we just haven't found it, YET! But the subconscious mind is a powerful tool and it works 24 hours a day. When it finally comes up with an answer, usually around 3:00 AM, I wake up and shout EUREKA!!! While that scares the bejeebers out of the dog, I jot down the answer and go back to sleep.

The latest "eureka moment" occurred at 4:05 in the afternoon on Tuesday, September 17, 2019. I wasn't asleep and it didn't scare anybody. It was when I realized what Allison's fans are really after is nothing less than his immortality. Since we don't know what plans, if any, President Trump may have for Glenn, we need other ideas. How about working through the Congress as suggested by the guy at the White House? What about trying to have legislation passed, by the Congress of the United States of America, which proclaims Glenn Richard Allison to be the original "Mr. 900." That may sound like a long shot, but you never know unless you try.

To make a long story short, the person I thought may be able to produce the necessary result is California's Representative, Doug Cisneros. He represents the 39th District, the location of La Habra 300 Bowl. I called his office and spoke to Joshua (no last name given). When I explained the situation, the excitement on the other end of the line was palpable.

The young man was so taken by the story of Glenn Allison that he disclosed a phone number and email address he probably shouldn't have. I accessed both, and to their credit, within hours they contacted La Habra 300 Bowl for information about Glenn. Unfortunately, they discovered that Glenn Allison made history in their district, but he is not a constituent because he lives in the 46th district.

The good news is that Congressman Cisneros' people were so excited about this story, they didn't just let it die. They handed it over to U.S. Representative Lou Correa's people because they thought Glenn Allison was one of his constituents. I have reached out to his office in Washington. I spoke to Esmeralda and offered all the help I could give. She now has all the pertinent information and has promised to look into the matter, though she didn't seem as enthusiastic as Cisneros' operatives.

The takeaway is this: The first job of any politician is to get re-elected. Their second job is to do everything in their power to ensure that re-election. The fact is, the passion generated by Glenn Allison's story still moves people, in this case, people in offices that are here to serve you. I was able to get a date by which to expect a reply. By coincidence, it is the same date as this edition of the Bowling News.

Some call it coincidence, others call it fate, karma, the law of averages, or even the hand of God. Whatever you call it, there are times when something very special happens in our lives. Sometimes it's amazing to ponder how those moments are interconnected to other people and/or events we know nothing about. Such is the case for the Glenn Allison saga.

It begins with a quiet and humble man named Allie Brandt. On Oct. 25, 1939, bowling in the small city of Lockport, NY, he set an all-time-high scoring record by delivering a sanctioned series of 886. In doing so, he rolled 3 scores most bowlers don't achieve in a lifetime. But he was no average bowler. He was a professional, a champion, and a hall-of-famer. He was also friends with many of those who governed the sport of bowling. He couldn't possibly know the controversies that series would create.

Along comes Ray Orf. Cut from the same cloth as Allie Brandt, he was the first to eclipse Brandt's record. On Feb. 6, 1972 he delivered a 3-game score of 890. Unfortunately, the American Bowling Congress took unprecedented actions which prevented the sanctioning of Orf's series. The only benefactor of this fiasco was Brandt. Rumors quickly circulated that the ABC's actions were done to protect the 886 record. Orf sued the ABC and they quickly realized their treatment of his score was wrong. They said, 'Sorry about that,' by paying him an undisclosed sum of money, but never reversed their decision. Orf's suit may have influenced another man he didn't know, one Bill Straub.

On Nov. 16, 1979, Bill Straub, another in the list of all-time greats associated with this story, rolled a 300 game/836 series; a local record. While his series did not challenge Brandt's record, the legal case it created influenced the future of the sport. Following in Ray Orf's footprints, Straub also sued the ABC and the case went all the way to the Nebraska Supreme Court. Rulings made by that court developed into "case law" which may have been improperly "cherry-picked," by lawyers for the ABC, to deny sanctioning the greatest series ever rolled.

While bowling 300 games was nothing unusual for Glenn Allison, delivering three in a row was. Nobody in history had ever done so during sanctioned competition. Imagine his disappointment when, after being told by the head of a team of four local inspectors, "Everything seems to be in order," a total stranger from ABC headquarters in Wisconsin shows up and says, 'No, it wasn't.'

Following the rules, as usual, Glenn appealed to the ABC, but was again told, "No." Following precedent set by both Orf and Straub, he also sued the ABC, or at least he tried to. For some unknown reason, his lawsuit wasn't allowed. It seems the lawyers for the ABC may have used a ruling from the Straub case to convince a judge to throw Allison's case "out the window."

That ruling was, "Members of the ABC agree, upon becoming members, to be bound by the ABC rules and to grant jurisdiction over all bowling disputes to the ABC." If they did this, it may have violated Allison's civil rights because other aspects of his suit were subject to court rulings. That's an inconvenient truth that would have to be covered up for generations. It would also affect the lives of hundreds who have served the institution we call bowling, as well as those who play the sport.

The effects of this controversy have reached into the hearts and minds of millions of bowlers. Many fans of Glenn Allison protested the injustice. Attempts to get his series sanctioned retroactively are numerous but short-lived. Phone calls have been made, petitions signed, and articles written about this travesty.

The USBC response to this issue has been cowardly. They play dead and ignore their members. They now sanction any honor score without question and refuse to even speak of Glenn Allison or his series. The lack of response is a clue that the USBC may be hiding something. Their lies, told to the public in 2014, * may be another.

As stated earlier, sometimes it's amazing to ponder how things are interconnected to other people and/or events we may not know about. The best way to overcome "not knowing" is to seek data. Though I have been told the records from Allison v. American Bowling Congress are no longer available, the case was so famous, copies must exist somewhere. If they do, The Perfect Game will find them. When we do, the "maybes" and "what ifs" will disappear from these articles. Stay tuned.






